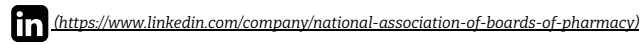
SUBMIT A CLAIM

Claim credits for activities provided by NABP by signing into **NABP's CPE Submission Site** (<http://nabp.learnercommunity.com/>) and following the steps below.

- Select the applicable live meeting or conference or scroll down to home study and e-learning courses.
- Enter the appropriate code distributed in each session and complete applicable tasks.
 - For **live meetings and conferences**, click "submit." You must complete course and speaker evaluations. For some live courses, you must also pass a post-test.
 - For **home study and e-learning**, click "redeem code." Be prepared to complete a course evaluation and pass the post-test.
- Select the appropriate credit (pharmacist or pharmacy technician), enter your NABP e-Profile ID and date of birth, and click "claim."

You must submit the activity code and claim your credit within 35 days (<https://nabp.pharmacy/help/what-is-the-deadline-to-submit-a-cpe-claim/>) of **completing the activity**. We recommend submitting your claims as soon as possible after you have completed the activity to ensure that the claim is processed and you receive credit.
