UNDERSTANDING THIS POPULATION

Survivors of trafficking and exploitation often present with unique treatment needs:

- · Safety concerns and heightened elopement risk
- Trauma bonds
- · Potential recruitment of others
- Frequent relapse
- Dissociation and other complex trauma symptoms

These needs can pose unique business challenges such as census management, budgeting, strategic planning, milieu structure, and establishing fundraising and marketing strategies without re-exploiting the population served.
