You can maximize the financial benefits even further with additional options such as 1 Pay Lease, Multiple Security Deposit and Low Mileage Lease programs, as well as the Excess Wear & Use Protection Plan (not available in New York).

ADDITIONAL DETAILS YOU SHOULD KNOW:

- There are mileage limits calculated by dividing the number of months in the term by 12 and multiplying this amount by 15,000 (standard lease) or 12,000 (low mileage lease).¹
- If there's any damage that's beyond normal wear, an excessive wear and use fee may be collected. The Excess Wear & Use Protection Plan can help you avoid these fees.
- A disposition fee will be applied at the end of your lease to help cover the costs to sell or dispose of your vehicle. We'll waive this fee for qualifying customers who lease or finance their next vehicle with LFS through a Lexus dealer.²
- You can return your vehicle at any time. However, early termination charges may apply, which can be substantial.¹

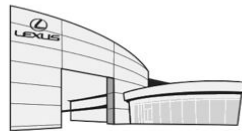

1. This information will be disclosed in your lease agreement. If mileage limits are exceeded, you may be charged additional fees at the end of your lease. See your lease agreement for details.
2. Offer to waive the disposition fee for qualifying customers in good standing with LFS who purchase/lease a new or certified used Toyota or a new or L/Certified Lexus within 30 days of lease return and finance/lease with TFS/LFS.
3. Please see your Lexus dealer for actual program parameters, terms, conditions and restrictions.
4. Refunds less all remaining amounts due and owing under the lease including without limitation costs such as excess wear and use, excess mileage, or disposition fee.
