ENGLISH TRANSLATION

A trademark registration is valid for ten years from the date of registration. Thereafter, the registration may be renewed for another ten year period. Applications for renewal can be made at the earliest six months before the ten-year period expires, and with an extra fee, within six months thereafter. The fee must be paid within the same period.

For applications filed on or after 1 January, 2019: A trademark registration is valid for ten years from the date of application. Thereafter, the registration may be renewed for another ten year period. Applications for renewal can be made at the earliest six months before the ten-year period expires, and with an extra fee, within six months thereafter. The fee must be paid within the same period.
