

## TRADEMARK TRANSFER AGREEMENT

This document certifies the trademark transfer agreement, which is entered into by:

On the one hand, Guillermo Ignacio Ricardo Dasso Arana, of Peruvian nationality, married, with National Identity Document (DNI) No. 46409320, businessman, domiciled for these purposes at Av. San Martín No. 154, district of Barraco, province and department of Lima, hereinafter referred to as Assignor; and,

On the other hand, Luigi Paino Felman, of Peruvian nationality, single marital status, with DNI No. 466001579, businessman; domicile for these purposes at Calle los Cedros 133 Urb. La Molina Vieja, district of La Molina, province and department of Lima, who will hereinafter be referred to as Assignee.

This act is celebrated under the following terms and conditions:

### FIRST: BACKGROUND

1.1. The Transferor owns the following brand:

1.1.1. DADA service brand, in class 43 of the Official Nomenclature, whose registration was granted by Resolution No. 0027514-2018 OSD - INDECOPI dated DECEMBER 12, 2018, with Certificate No. S00112147.

### SECOND: PURPOSE OF THE CONTRACT

By this document, Assignee transfers to Assignor the ownership of 50.00% (Fifty percent) of the brand(s) described in the first clause. For its part, Assignee undertakes to pay Assignor the total amount of the price agreed in the following clause in the agreed manner and opportunity. As a result of the act held, the parties will share joint ownership of the brand.

### THIRD: PRICE

By this document Assignor transfers to Assignee the ownership 50.00% (Fifty percent) of the brand(s) described in the first clause of this Contract, amounts to the sum of S/. 300.00 (Three hundred and 00/100 Soles).

#### FOURTH: METHOD OF PAYMENT

The parties agree that the price indicated in the third clause of this document will be paid in cash, in full and in cash, on the date of signing this document.

FIFTH: The parties agree that all the expenses that originate the execution and execution of this contract will be assumed by Assignee among said expenses, the certification of the signatures by a Notary and the registration of the amending act before the Office of Distinctive Signs of INDECOPI, for the purposes of registering the change of owner of the trademarks being transferred.

SIXTH: the parties agree that any litigation, lawsuit, controversy, doubt, discrepancy or claim resulting from the execution or interpretation of this contract or its annexes and complementary or modifying documents or related to it directly or indirectly, as well as any other cause related to this document, will be submitted to an Arbitration process.

SEVENTH: For the validity of all communications and notifications to the parties due to the execution of this contract, both indicate as their respective addresses those indicated in the introduction of this document. The change of domicile of any of the parties will take effect from the date of communication of said change to the other party by notarial means.

EIGHTH: In matters not provided for by the parties in this contract, both are subject to the provisions of the Civil Code and other applicable legal system regulations.

As a sign of agreement, the contracting parties sign this document, on the 06th day of the month of April 2022.
