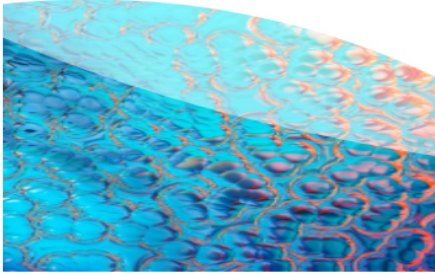

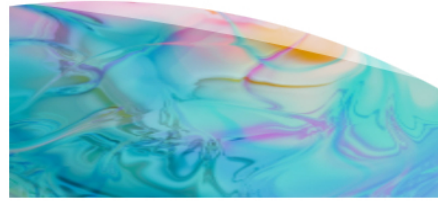

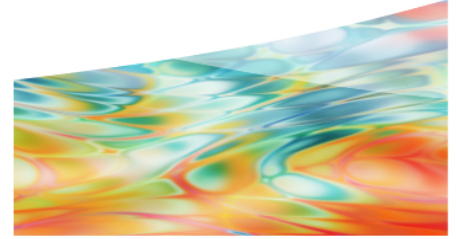
Operationalized the ACO Model
