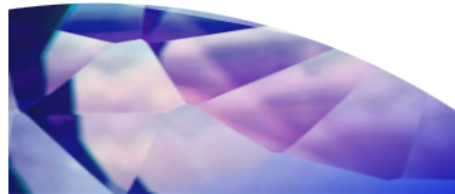

We use artificial intelligence to explain disparities in health outcomes in small geographic areas. Our model draws on over 150 variables across 10 domains of social risk factors to create a proprietary composite Local Social Inequity score that can be used to evaluate interventions aimed at reducing disparities.
