Applicant requests registration of the above-identified mark in the U.S. Patent and Trademark Office on the Principal Register established by the Trademark Act of July 5, 1946 (15 U.S.C. §1051 et seq.) for the following goods/services:

Class 35 -- designing, planning and production of sales presentations and marketing programs all relating to the marketing, sale and management of residential and commercial properties for others; the operation of a program that assists buyers in acquiring a residential dwelling; the operation of a program that assists buyers to reduce the cost of acquiring and owning a residential dwelling; hotel management;

Class 36 – Sale of residential and commercial real estate projects and developments; financing, lending and mortgage services for residential homes and commercial buildings; rental and leasing services for residential homes and commercial buildings; real estate management; consulting and advisory services in relation to real estate and real estate development and management; the operation of a business building, selling or renting residential dwellings and commercial and industrial buildings;

Class 37 – Real estate development services; construction and maintenance of residential and commercial real estate projects and developments; residential home construction services; construction of residential single and multi-family residences; commercial building construction services; residential and commercial subdivision construction services; real estate projects and land developments; general building construction contracting services;

Class 42 – Designing and planning residential and commercial real estate projects and developments; residential and commercial subdivision planning services; architectural, engineering and interior design services in relation to residential and commercial buildings, real estate projects and land developments; the operation of a sales and design center and showroom providing sales assistance, interior design and architectural selections and options for home buyers; online home design and decorating services;

Class 43 – Hotel services

Applicant has a bona fide intention to use the mark in commerce on or in connection with the above-identified goods/services. 15 U.S.C. §1051(b).
