# TRADEMARKS FOR GOODS, TRADE OR SERVICES

## CERTIFICATE OF TRADEMARK IDENTITY

### Intellectual property Code - Book VII

**Art. L. 712-1.** Ownership of the trademark is acquired through its registration. The trademark may be acquired jointly.  
Registration comes into effect from the filing date of the application, for an indefinitely renewable period of 10 years.

**Art. R. 714-2.** The National Trademarks Registry is kept by the Institut National de la propriété industrielle (French Patent Office).

For each trademark, it shows :

- 1) The applicant's identity and the references of the registration, as well as subsequent deeds modifying its existence or scope ;
- 2) Deeds modifying the property of the trademark or the use of the rights attached thereto ; in case of a property claim, the corresponding summons ;
- 3) Changes in names, legal status or address, as well as corrections of material mistakes made in registered data.

No entry will be made into the Registry so long as the registration has not been published in the conditions provided for in Article R.712. 8.

**Art. R. 714-8.** Any registration entered into the National Trademarks Registry will be published in the Bulletin Officiel de la Propriété Industrielle.

The Patent Office can supply any applicant with the following :

- 1) A certificate of identity including the trademark model, information relating to its filing and registration, and if any, the limitations of the list of products or services resulting from a withdrawal, a waiver or a legal decision ;
- 2) A copy of registrations entered into the National Trademarks Registry ;
- 3) A certificate stating that no registration exists.

The Director of the Institut National de la Propriété Industrielle (French Patent Office) certifies that the trademark as shown hereunder was registered and published in the Bulletin Officiel de la Propriété Industrielle.

In addition, he certifies that the National Trademarks Registry shows that :

- The trademark is not subject to any limitation of the list of products or services resulting from any withdrawal, waiver or legal decision.
- The trademark has been subjected to a limitation of the list of products or services resulting from the withdrawal(s), the waiver(s) or the legal decision(s) listed in the National Trademarks Registry and shown in the schedule of the present certificate ( document(s) )
- The trademark was subjected to a decision revoking totally or partly the registration (enclosed with the present certificate) ;
- The trademark was subjected to the renewal declaration(s) shown and attached to the present certificate.
- The trademark was not subjected to any renewal declaration.

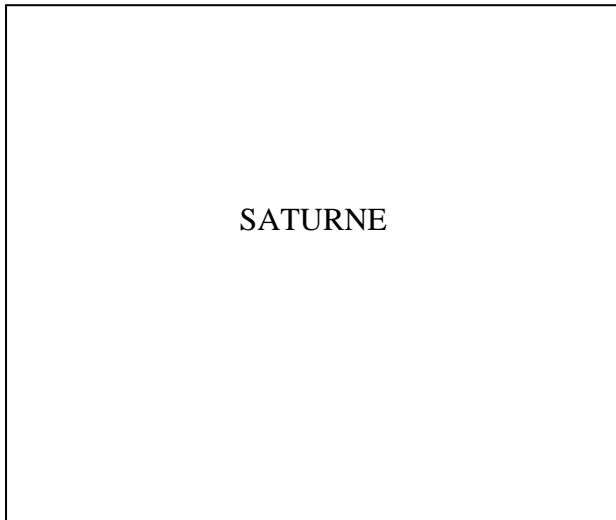
