

Compared to solvent extracted soybean meal, ExPress[®] soybean meal contains highly digestible protein, energy. Because of the chemical-free, mechanical process, ExPress[®] soybean meal has lecithin and natural antioxidant tocopherols. ExPress[®] soybean meal has higher residual oil and higher amino acid digestibility that allows greater flexibility in feed formulation. - 1. TERMS OF SALE. These Standard Terms and Conditions ("Terms and Conditions") govern all sales of products ("Products") and services ("Services") by HEARTLAND AGRI PARTNERS LLC D/B/A INSTA-PRO INTERNATIONAL AND ITS AFFILIATES ("Seller") to the individual or entity ("Buyer") set forth on the Purchase Agreement to which these standard terms and conditions are attached ("Purchase Agreement"). Upon execution of the Purchase Agreement, the Terms and Conditions, along with the Purchase Agreement, shall constitute a binding agreement. In case of a conflict between these Terms and Conditions shall control unless the provisions set forth in the Purchase Agreement expressly state that they are intended to supersede the Terms and Conditions. No additional, modified or altered terms are accepted by Seller notwithstanding the terms set forth in any writing, purchase order, invoice or other communication from Buyer. Buyer agrees to keep the terms of the Purchase Agreement communication
- PRICE AND ACCEPTANCE. Prices are subject to change in the event of increase in our supplier's prices or extension of delivery date beyond our control and shall become firm only when deposit is received or an approved letter of credit is in place.
- 3. DELAYED SHIPMENT. If equipment is not shipped within 30 days of equipment completion, due to the fault of the Buyer, Buyer shall pay a holding charge of .5% per month on total Purchase Agreement value. After 90 days of such finished equipment storage, Seller may cancel Seller's obligations under the Purchase Agreement, sell the applicable equipment to another purchaser and retain Buyer's deposit in which Buyer's rights will then be forfeited.
- SECURITY INTEREST. Buyer grants to Seller a purchase money security interest in and to all items sold by Seller to Buyer until such time as Buyer has paid all amounts owed to Seller.
- CANCELLATIONS. Buyer may cancel the Purchase Agreement only with Seller's written consent, and in such event Buyer shall forfeit the deposit as well as make a mutually agreed termination payment.
- 6. TAXES. Buyer is responsible for paying all applicable taxes.
