- Troubleshoot GPS Loss, discovered that when comms are transmitting on frequencies in the 121 band it interferes with GPS signal. Re routed coax for comm and GPS antennas, installed notch filters on comm coax cables. Relocated and installed new Comant CI-122 VHF antenna IAW AC 43.13 2B. Re located existing Rami antenna and mounted IAW RAMI inc Installation Instructions document number 27-1651-4B Dated Jan. 2019. VHF interference checks were performed and no faults were found. Installed (2) P/N 4-70-54 4-70 Notch Filter, Installed P/N CI-122 VHF Nav Antenna.
- Duplicated push to talk issue. Discovered message on the GNC "GNC needs service". Contacted Garmin and determined it was a failed unit. Sent to Garmin for RMA replacement and installed new unit IAW Garmin Maintenance Manual with ICA, GPS 175/GNX375/GNC355 Part 23 AML STL (Garmin Doc No. 190-02207-A2 Rev 3 dated March 1, 2023) Installed P/N 010-02232-51 - GNC 355 S/N: 5YR006113.
- Troubleshoot vacuum leak. Found loose hose connection at the back of the attitude indicator. Added band clamp and tightened connection to the attitude indicator. Performed engine run and vacuum leak still present and audible. Existing attitude indicator was found to be leaking from the case around the unit face.
