DECLARATION UNDER SECTION 8 OF THE TRADEMARK ACT OF 1946

I, James R. Pugh, declare:

1. That Liberty Mutual Insurance Company, a Massachusetts corporation, own the above-identified registration issued July 8, 2003 as shown in the records in the Patent and Trademark Office.

3. That such mark is still in use as evidenced by the specimen included showing the mark as currently used.

4. That all statements made herein of his own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the registration concerning which it is made.
