"Drink coasters; mugs; travel mugs; drinking glasses; cocktail glasses; beer glasses; beer steins; wine glasses; shooter glasses; champagne flutes; martini glasses; drinking flasks; goblets; water bottles; vacuum bottles; bottle openers; corkscrews; ice buckets; cocktail shakers; pitchers; decanters; glass carafes; Thermal insulated containers and bags for food; thermal insulated bags for beverages; cooler bags; insulating sleeve holder for beverage cups; Cookie cutters; cookie jars; oven mitts; cooking utensils; cookware and bakeware; dinnerware; china dinnerware; bowls; plates; serving dishes; picnic baskets; serving trays; napkin rings; candlesticks; incense burners; candle holders; vases; ashtrays; hair brushes; paint brushes" in International Class 21.
