

**APPLICATION FOR COMBINED TRADEMARK

TO THE COMMISSIONER OF PATENTS AND TRADEMARKS:

Cleanline Surf Co. is a corporation of the State of Oregon, located and doing business at 60 N. Roosevelt Drive, Seaside, Oregon 97138.

The above-identified Applicant requests registration of the above-identified mark, shown in the accompanying drawings, in the United States Patent and Trademark Office on the Principal Register established by the Act of July 5, 1946 (15 U.S.C. § 1051 et. seq. as amended) for the following goods and services: beanies; caps; headwear; hoodies; infantwear; jackets; shirts; tank tops; t-shirts in International Class 25; skateboards; surfboards in International Class 28; and on-line retail store services featuring surf gear, kite boarding gear, stand-up paddle gear, skate gear, kayak gear, wetsuits, backpacks, bags, towels, stickers, apparel, footwear, eyewear, and watches; retail store services featuring surf gear, kite boarding gear, stand-up paddle gear, skate gear, kayak gear, wetsuits, backpacks, bags, beach towels, stickers, apparel, headwear, footwear, eyewear, and watches in International Class 35.

Applicant has adopted and is using the mark shown in the accompanying drawings for the above-identified goods and services.

The mark was first used for t-shirts in International Class 25 at least as early as December 31, 1985; was first used for t-shirts in International Class 25 in interstate commerce at

least as early as December 31, 1985; and is now in use in such commerce for all of the identified goods in International Class 25.

The mark was first used for surfboards in International Class 28 at least as early as December 31, 1985; was first used for surfboards in International Class 28 in interstate commerce at least as early as December 31, 1985; and is now in use in such commerce for all of the identified goods in International Class 28.

The mark was first used for retail store services in International Class 35 at least as early as December 31, 1980; was first used for these services in International Class 35 in interstate commerce at least as early as December 31, 1980; and is now in use in such commerce for all of the identified services in International Class 35.

Specimens showing the mark as actually used are presented herewith.


