Certain vegetative plant fibers can help aid with digestive ailments but there are other benefits with certain types of plants; such as hemp, with the advent of newer strains containing higher levels of beneficial molecular elements which offer additional health benefits to pets other than digestive care.

BARKs is that product for pets which will provide not only vegetative fiber for digestive benefit but with the higher level of CBAs (Cannabisin-A), CBDs (Cannabigerol) , CBGs (Cannabidiols) and CBNs (Cannabinols); as well as many more beneficial molecular elements for overall health. With pet ailments being on the rise just as with human afflictions, an all around pet supplement is needed now more than ever. **BARKs** is designed to be a well rounded pet treat developed to help pets with a wide range of ailments along with preventative care; in other words; one pet treat that addresses a multitude of pet health issues.

Extending you pets life and quality of life....

Making up the center of the product are multipurpose supplements for the one product that covers your pet's entire health needs, comprised of the components which help maintain pet's health for digestion, bones, teeth, eyes, coat, joints, and to help aid with disorders for ligaments, fleas, ticks, parvo, distemper, tumors, blood and nervous system. Constructed of organic hemp from southern Colorado containing high levels of CBAs, CBDs and CBNs elements which are currently on the forefront of leading edge molecular biotechnology for treatment of neurological and cancer related disorders; as well as, treatment of other ailments. Made with all natural ingredients, there are no synthetic additives, corn fillers or wood pulp and is also GMO and gluten free. While other companies may use products from foreign suppliers, be aware that where these products come from quality control standards are much lower and may even come from areas which may have pollutants in agricultural areas. With pet health being one of the fastest growing areas of pet care, the need for effective alternatives to drugs and medications are becoming more necessary than ever.

A durable retrievable pet treat that pet owners can interact with pets and give them a treat at the end of playtime...

BARKs is constructed to be eaten by your pet as a treat in 1-3 day. Patterned after natural tree bark, there are four types simulating Pine, Cypress, Redwood and Oak. The accentuated patterns create an irregular surface structure which can clean your pet's teeth while consuming the product. Even though

BARKs look like wood there are NO wood products or synthetics used in its construction.

A pet's best friend.....

Overview:

A flavored or unflavored pet treat using hemp based products and byproducts in order to provide pets the beneficial support from cannabanoids such as CBAs, CBDs and CBNs for which may help treatment of ailments such as arthritis, hip pain, tumors, leukemia, cancers, organ tissue repair and neurological regeneration; as well as, fiber support for teeth and digestive system health. A viscous version of the product in the form of baby food may be produced for tube feeding pets with more advanced debilitations. Wherever and whenever possible and practical, natural organic processes will be utilized to produce the highest quality results. (See FIGURE "A") Regular use of product can provide a loading of beneficial elements for overall pet health.

Narrative:

The treat will be shaped into the forms of sticks for the various sizes. The outer "shell" of each shape shall be from ground plant fibers with bone meal additives and formed by compressing the shell material into these forms and will have texture finished simulating the different tree barks. There will be four (4) main types; Cypress, Pine, Oak and Redwood, other tree shapes and associated bark patterns may also be used. Each tree type shall also be processed with an associated color. The shell may be glazed with a flavored sealant to give a more realistic appearance. The glaze may also contain a preservative to help lengthen shelf life and/or add waterproofing. The center shall be a nutritious paste filling resembling the meaty center of natural bones and will contain a mixture of meat byproducts and plant materials. Calcium or bone meal may be added for additional bone health support. Fish byproducts or fish oil may be added to provide Omega 3 or 5 fatty acids.

Process:

Utilizing the raw material from hemp plants such as the leaves, stems, stalks and seeds in the production of a pet treat which will contain from 5% to 40% beneficial cannabanoids for the treatment of pet's physical chronic and acute conditions, ailments, or diseases. The raw material will be prepared by a procedure resulting in the manufacturing of the end product. The initial preparation shall be the cleaning of the raw materials by stream bath to remove contaminants and help start the breakdown of plant material. Additional cleansing agents may be added to the process such as distilled vinegar, peroxide or baking soda to help aid with the preparation process.

After cleansing, stems and stalks shall be pulverized in order to render the plant fibers into a more easily digestible form which also allows for the forming of the finish product. Bone meal and calcium may be added to the outer shell form to make it more appealing and add nutrient benefit. The leaf and seeds shall also be cleaned accordingly but will be prepared by crushing in order to leave it closer to its original state and provide an amount of visible vegetation. The leaves and seeds will be suspended in a center material which will be made of meat or meat byproducts and emulating the form of a meaty center as with marrow in natural bones. The center mixture will also contain any fish or fish oil products for joint health. For pets with more advanced debilitations the mixture will have higher percentages of cannabanoids and may be processed into a viscous mixture depending on the pet's level of debilitation. Natural preservatives may be utilized, if needed, in order to achieve a reasonable shelf life for the product.

Testing:

A milligram evaluation shall be made in order to determine the effective volumes of beneficial ingredients in order to achieve effective levels. The testing laboratory may also provide direction to determine the potential of shelf life for the product. Testing shall be conducted on every batch for the breakdown of molds, mildews, pesticides or poisons. Results shall be provided to the public from the corporate website for review.

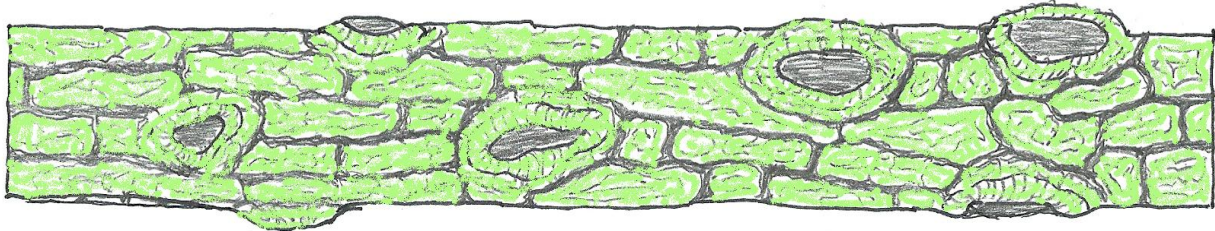

Currently hemp is being provided from hemp farmers in south Colorado.

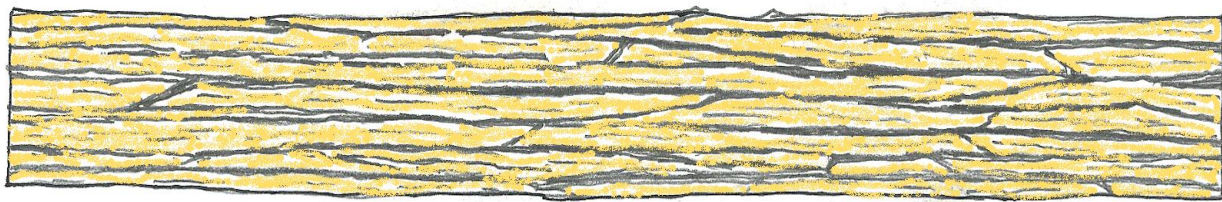

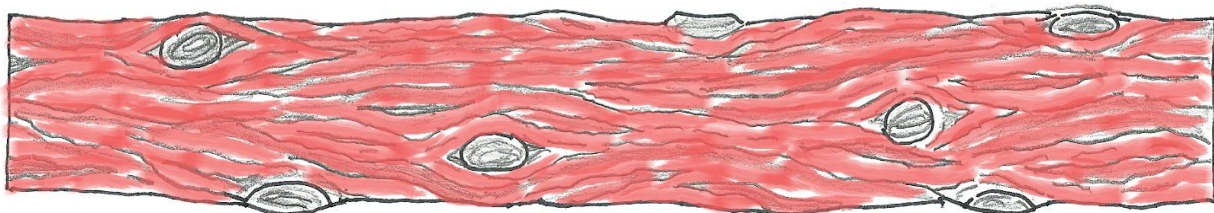

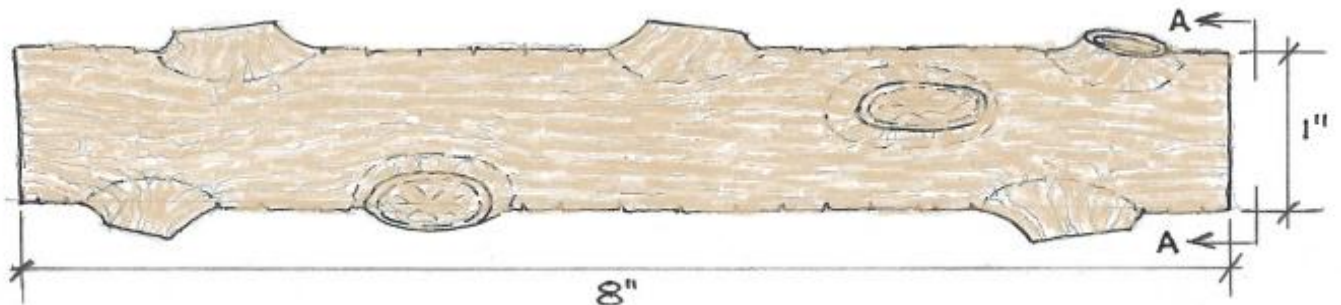
PINE BARK



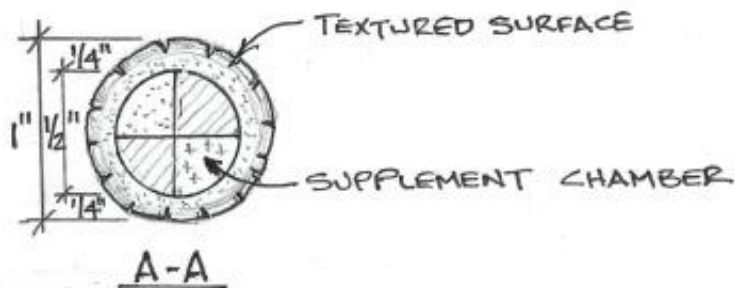
CYPRESS BARK
