FIRST AID STATEMENTS

TO CLEAN AND DISINFECT: This product can be used to clean and disinfect hard, non-porous surfaces. This product can be used on all non-food contact surfaces including the exterior surfaces of appliances. Apply the product full strength with a clean sponge or cloth until the surface is thoroughly wet. Let stand for 10 minutes and then wipe clean with a wet sponge or cloth or rinse the surface with water. For heavily soiled surfaces, a precleaning is required. Do not use with chlorine bleach or any other chemical product.

TO CLEAN: Use this product to clean hard, non-porous surfaces. This product can be used on all non-food contact surfaces including the exterior surfaces of appliances. Prior to use, mix ¼ cup of this product with one gallon of water. Apply the diluted solution with a clean sponge, cloth, mop or brush to surfaces and keep surfaces wet for 10 minutes. Then wipe clean with a wet sponge or cloth or rinse with water. Do not use with chlorine bleach or any other chemical product.

STORAGE AND DISPOSAL: Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store in a cool, dry area. Always store pesticides in the original container. Store out of reach of children.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.
