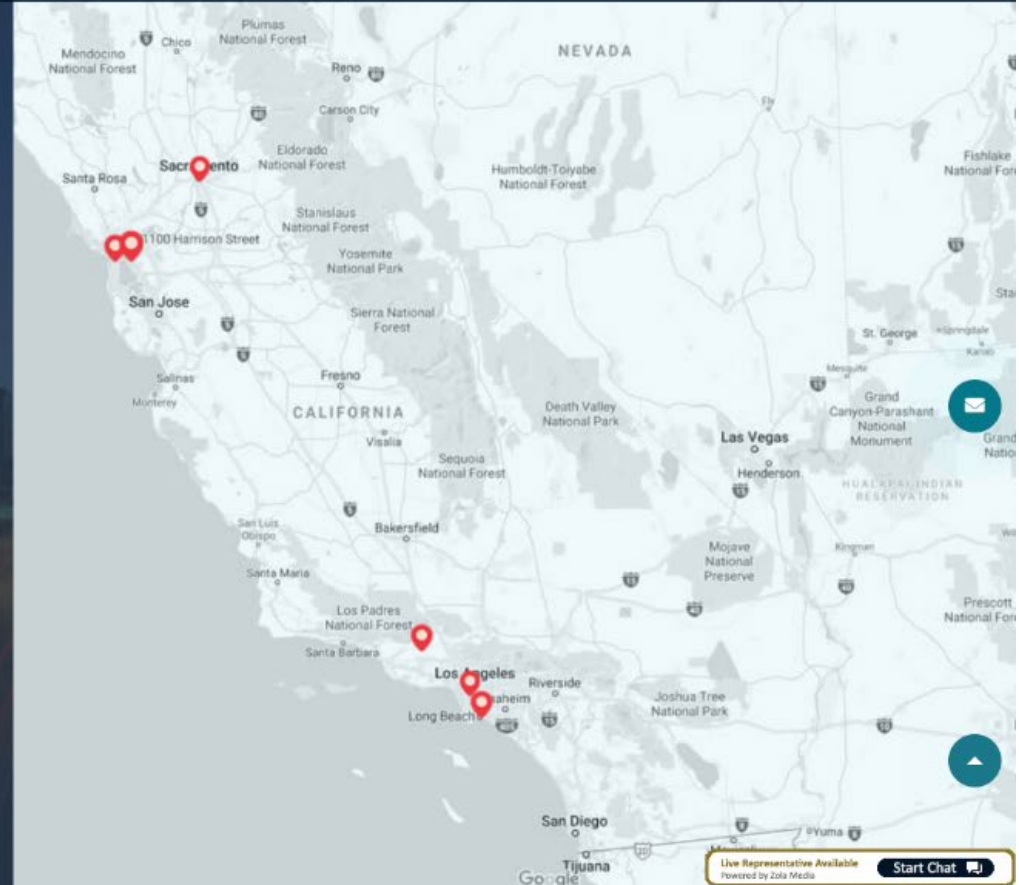

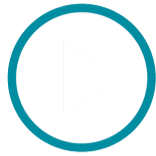

principle of “comparative fault” (“shared fault”) following a pure comparative negligence standard. This means that even if you were partly at fault for the accident that injured you, you may still collect damages, but the percentage of your fault, determined by the court, will be deducted from your awarded compensation.

To illustrate: if you are found to be 25 percent at fault in a car accident because you were driving over the speed limit, and you are awarded \$100,000 in damages, you will receive only \$75,000. In California, even if you bear most of the fault for the accident, you are still entitled to damages from the other party proportionate to that party’s percentage of liability.

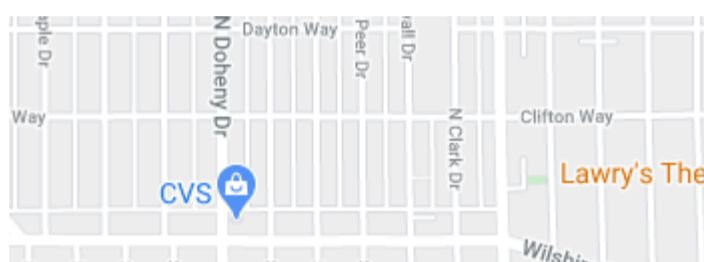

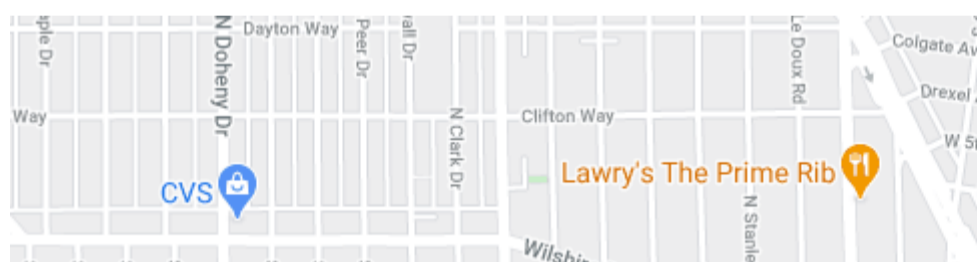

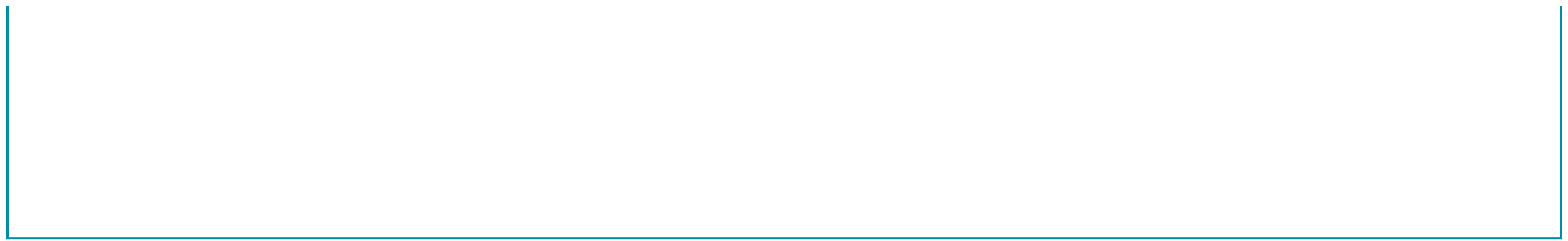
