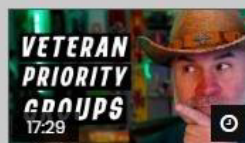

I was just diagnosed with obstructed sleep apnea and possibly restless syndrome in February 2021 and being issued a CPAP device this month. I, also have a C&P examination with LHI coming up in April for PTSD. My question is should I wait to file a claim for my sleep apnea after my PTSD C&P examination and my possible VA rating for a secondary claim. I am not sure how to accomplish all of this, being doing it on my own for the most part.

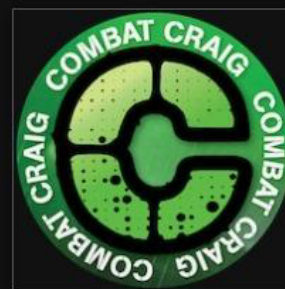
