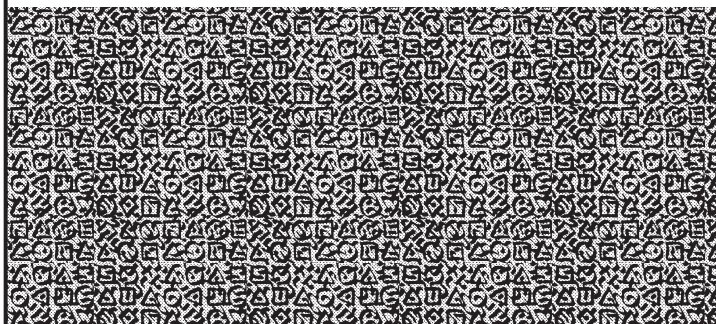

Shipping Charge

You will be assessed a shipping charge on your order, if applicable, no matter where it ships. When applicable, if you would like an order shipped to you at an alternative service method, other than standard, the alternative service method's shipping charge would apply.

1. We will not assess you any additional shipping charges when you contact us, and we'll send you: (a) replacement product as a result of our manufacturer's defect ("Replacement"), or (b) a product that we failed to include with your original order ("Missing Item").
2. Subject to change in accordance with applicable laws, shipping charges are taxable in all U.S. States and Territories, except AK, DE, IA, ID, MA, MT, NH, OK, OR, UT, WY, Guam, U.S. Virgin Islands, Northern Mariana Islands and American Samoa.
3. We update our system from time to time in accordance with specific State and U.S. Territory tax laws. Please contact our Tax Department at tax@thirtyonegifts.com for any questions about taxes on shipping charges.
4. A shipping charge will be applied to orders shipped to APO/FPO locations, or, when applicable and chosen, alternative service method shipping charges, noted above, would apply.

Notice of Cancellation

You may cancel this transaction, without penalty or obligation, within THREE BUSINESS DAYS (FIVE BUSINESS DAYS FOR ALASKA RESIDENTS; FIFTEEN DAYS FOR NORTH DAKOTA RESIDENTS SIXTY-FIVE YEARS OR OLDER FOR PURCHASES OVER FIFTY DOLLARS) from the date of transaction. If you cancel, you must make available to Thirty-One Gifts ("Thirty-One"), in substantially good condition as when received, any goods delivered to you under the terms of this sale. If you wish, you may comply with Thirty-One's instructions regarding the return shipment of products at Thirty-One's risk and expense. If you do make the products available to Thirty-One, and Thirty-One does not pick them up within 20 days of the date of your notice of cancellation, you may retain or dispose of the products without further obligation. If you fail to make the products available to Thirty-One, or if you agree to return the products to Thirty-One but fail to do so, then you remain liable for the performance of all your obligations under the terms of this sale. Return Policy

At Thirty-One Gifts, we want you to be completely satisfied with your purchase. If for any reason a product does not meet your expectations, please contact your Consultant within 90 days of your purchase date or within 90 days of the order shipment date by Thirty-One, whichever is later. Personalized items may only be returned due to our manufacturer's defect or upon further review by Thirty-One.

For a replacement item request due to our manufacturer's defect ("Replacement Item") or a Missing Item request, we will not assess any additional shipping charges to you when we ship the Replacement Item or Missing Item to the original address on your order. Additional charges may apply if you request a different shipping address from your original order.

For a product exchange request not due to our manufacturer's defect ("Product Exchange"), such as when you change your mind about a product you ordered and want a different item, we reserve our right to require you to return the original product to us at your expense. You will be responsible for a shipping charge on the product exchange, if applicable. Taxes on these shipping charges may also apply. We cannot issue Product Exchanges for products that have been personalized (except as noted in the first paragraph of this Return Policy), that are not in

good and resalable condition in their original packaging or that were otherwise designated by us as nonreturnable, discontinued or seasonal.

For a refund request not due to our manufacturer's defect ("Refund"), such as when you change your mind about a product and want a Refund on that product, we will not refund to you our shipping charges, if applicable, that you paid on your original order. We will only refund the price you paid for the applicable product and any taxes directly assessed on that product, as shown on your original sales receipt. We will not issue a Refund on any taxes directly assessed to you on these shipping charges. We reserve our right to require you to first return the product to us at your expense before we issue you a Refund.
