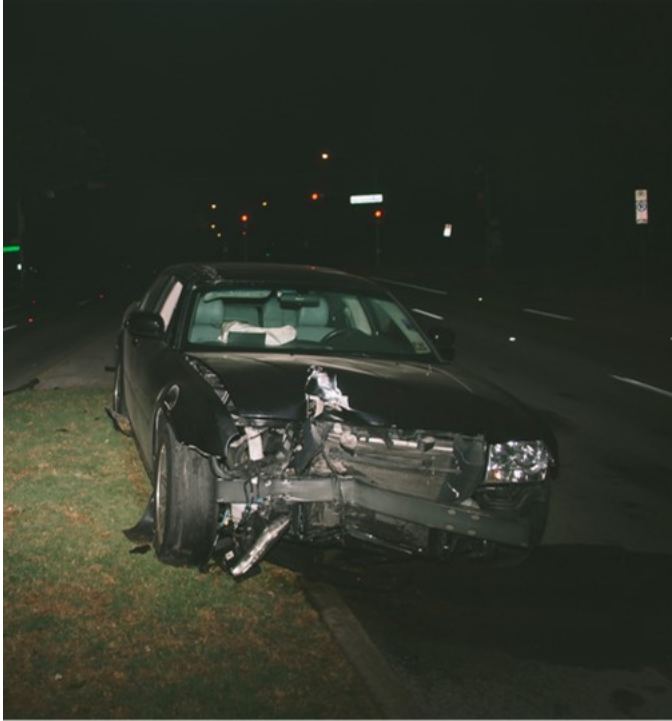

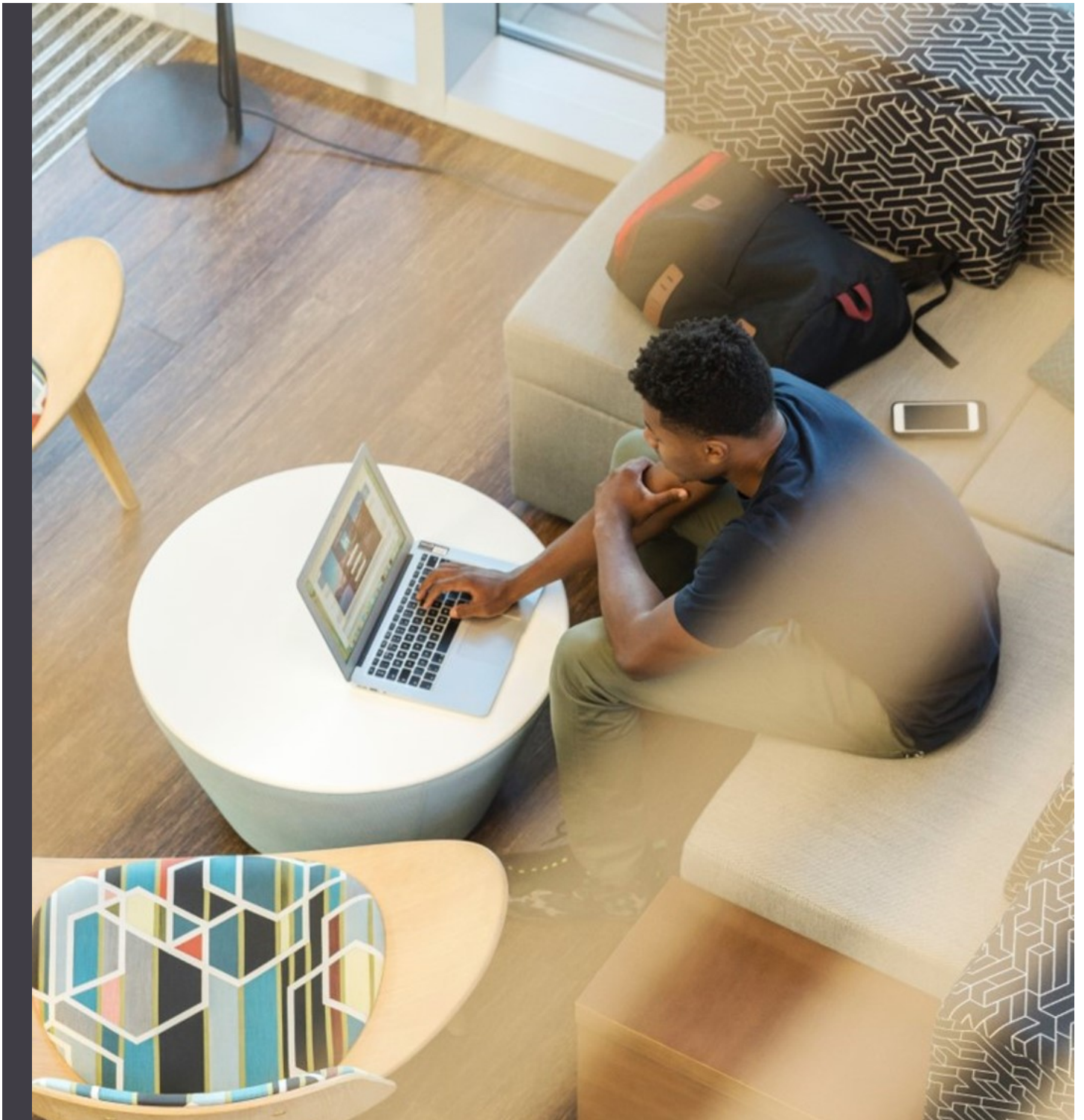

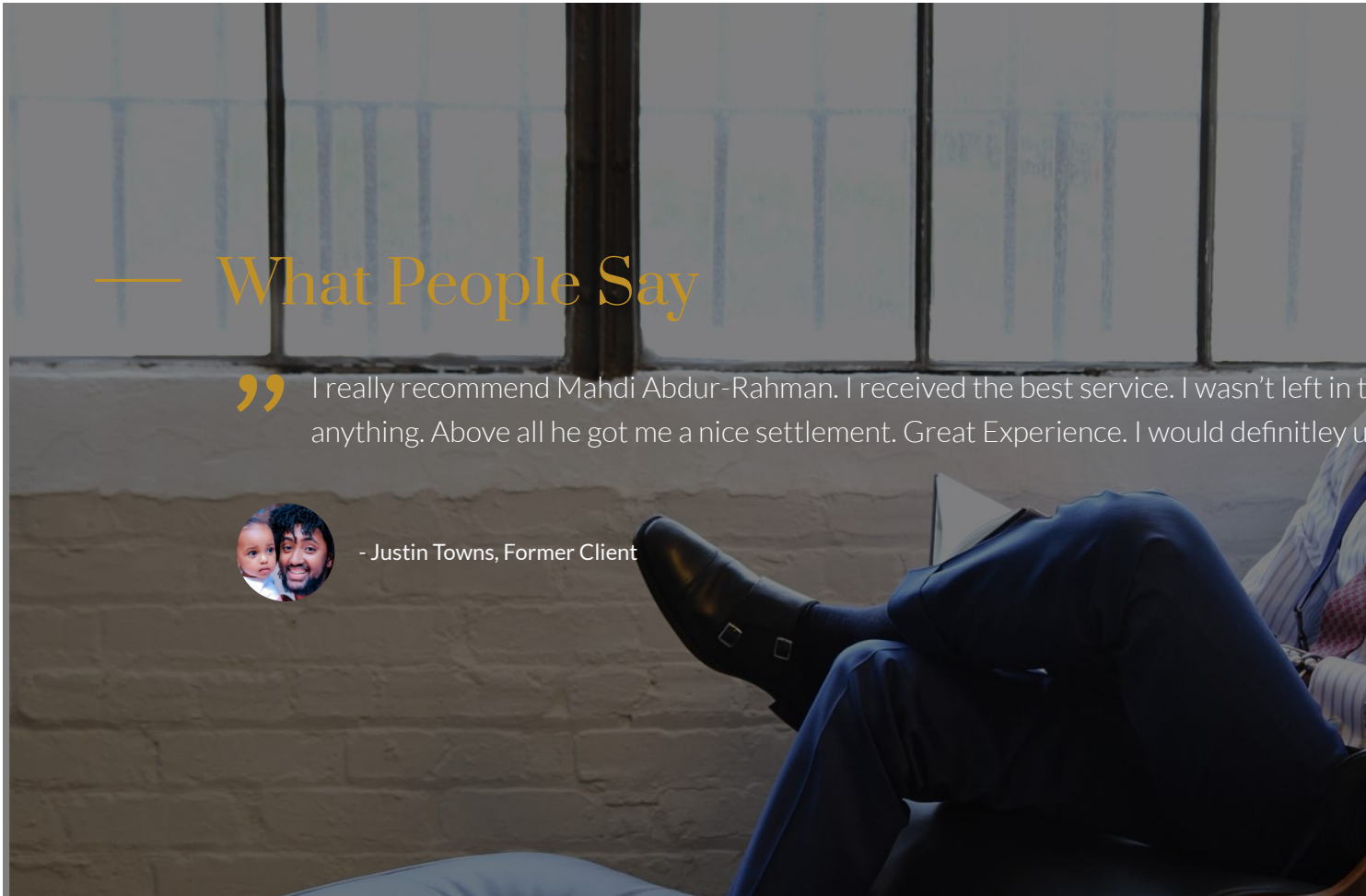




Workers Compensation
