Rules / Regulations

OFFICIAL RULES

Thank you for supporting the “I AM HOME™ WILLOW BRANCH NEW HOME RAFFLE 2021” (the “Raffle”), conducted by Vanderbilt University Medical Center (“VUMC”) and e3 Partners Ministry, Inc. d/b/a/ I Am Second (“e3”) (collectively, the “Sponsors”). Your purchase of one or more Raffle ticket(s) signifies your full and unconditional agreement to these official rules (the “Official Rules”). In the event of any dispute, the interpretations and determinations by the Sponsors regarding the application of these Official Rules is final and binding in all matters related to the Raffle. Void where prohibited or restricted by law, rule or regulation. All applicable federal, state and local laws apply. Tickets may sell out before the date of the Raffle drawing. The chances of winning are based on the number of valid tickets sold.

Eligibility

To be eligible to purchase a Raffle ticket, you must be an individual person at least 18 years old or the age of majority in your jurisdiction of residence, whichever is older as of the date of entry, and physically located within the State of Tennessee at the time of purchase. The following persons are not eligible to purchase a Raffle ticket:

Tickets

Tickets may be reserved via www.iamhomeraffle.com (the "Official Website"). You must provide all required information via the designated sections and/or pages of the Official Website to be eligible to enter and win. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.

Tickets may be reserved for \$100.00 each. There is no limit to how many tickets may be purchased per transaction or by any one individual during the Raffle Period.

A valid ticket represents a chance to win the opportunity to accept an offer of the Prize. All sales of tickets are final, and no refunds will be paid.

Tickets, the Prize, receipts, and any winner's rights are not transferable. A ticket purchased by an ineligible person is void, and cannot be a winning ticket. No refunds will be made to ineligible purchasers. Tickets may not be resold. No refunds, replacements, discounts or complimentary tickets will be issued.

Purchasing a Raffle ticket constitutes your unconditional acceptance to these Official Rules.

Winning the Prize is contingent upon fulfilling all requirements set forth herein. Sponsors reserve the right to verify the eligibility of winner.

Sponsors reserve the right to reject any ticket reservation request that is submitted with payment that does not constitute "good funds." A ticket issued in exchange for a check returned for "insufficient funds," or for a credit card charge that was "declined," or reported as "invalid" or "stolen" is void, and cannot be a winning ticket.

The IRS has ruled that a payment for a raffle ticket is a tax-deductible charitable contribution only to the extent the amount of the payment exceeds the price of the ticket.

All ticket reservations must be received and/or purchased by the indicated deadline. Any orders received after these deadlines will be ineligible. Sponsors assume no responsibility for any failure to receive orders or deliver receipts prior to the drawing deadline. All defective or physically altered tickets or entry forms will be disqualified.

The Drawing

The Raffle starts on August 31, 4pm (subject to change) Central Time and ends on November 27, 12:00pm Central Time (the "Raffle Period"). VUMC's computer is the official time-keeping device for the Raffle. The winning ticket for the Prize will be selected by a random drawing on November 27, 2021. The date of the Raffle drawing is subject to all laws, regulations and acts of God or other acts or circumstances that would render the drawing illegal, unreasonable or impractical. Sponsors will select the name of potential winner of the Prize in a random drawing from all eligible Raffle tickets. All valid tickets have an equal chance to win. Ticket purchasers need not be present to win.

Prize

The Raffle winner shall be entitled to receive, upon compliance with these Official Rules, a new home located at 3000 Whitstable Court, Thompson's Station, Tennessee 37179 (as further pictured and described on the Official Website (excluding any furnishings)) (the "Prize"). The Prize is strictly limited to those elements described in these Official Rules. The Prize is not transferable or assignable and is the sole prize in the Raffle.

Winner

The Prize will be awarded to only one (1) winner. If the Raffle ticket has more than one name on it, the Prize will be awarded to the eligible individual whose name appears first on the ticket. That individual is solely responsible for allocating the value of the Prize among the purchasers (if more than one). Sponsors will first notify the Prize winner by calling the telephone number provided as part of the applicable Raffle ticket purchase. Once the Sponsors notify the Prize winner via phone, Sponsors will send an Affidavit of Eligibility and Liability/Publicity Release (the "Affidavit and Release") (unless otherwise prohibited by law) by secure electronic communication or certified U.S. mail, return receipt requested, to the email and/or mailing address provided by the Prize winner. If a

winner cannot be contacted by phone, in the first instance, or by certified mail or email, and fails to respond to Sponsors within ten (10) days after the date the winner was notified in each case, the Prize is forfeited and no substitute or alternative prize will be provided.

The Prize winner will return the Affidavit and Release (as defined below) and the W-9 (and forms of identification) within ten (10) days after the date. Prize winner receives the written notification from Sponsors.

The winner of the Prize shall have no rights in or to the Prize itself until the winner has been verified as eligible by Sponsors, has timely executed the Affidavit and Release and returned it to Sponsors, and until delivery to and acceptance of the Prize by the winner has been completed. Until that time, as between Sponsors and the winner, the Prize remains the sole property of Sponsors. EXCLUSIVE JURISDICTION AND VENUE FOR ALL MATTERS RELATED TO THIS RAFFLE SHALL BE IN THE STATE COURTS OF DAVIDSON COUNTY, TENNESSEE, OR THE UNITED STATES DISTRICT COURT FOR THE MIDDLE DISTRICT OF TENNESSEE, NASHVILLE DIVISION, AND SPONSORS AND PARTICIPANTS HEREBY AGREE AND CONSENT TO SUCH JURISDICTION AND VENUE. As a condition of participating in this Raffle, each participant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Raffle, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Tennessee having jurisdiction. Further, in any such dispute, under no circumstances shall any participant be permitted to obtain awards for, and each participant hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e., costs associated with entering this Raffle). Participant further waives all rights to have damages multiplied or increased.

If, for any reason, the Raffle is not capable of running as planned, including infection by computer virus or bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsors (or any of the other Released Parties) which corrupt or affect the operation, administration, security, fairness, integrity, or proper administration or conduct of this Raffle, Sponsors may, in their sole discretion, void any suspect entries and (a) cancel or terminate the Raffle (or any portion thereof); (b) modify the Raffle or suspend the Raffle to address the impairment and then resume the Raffle in a manner that best conforms to the spirit of these Official Rules; and/or (c) award the Prize from among the eligible, non-suspect entries received up to the time of impairment, and all eligible entries received.

Frequently Asked Questions

GENERAL QUESTIONS

Note: If you are experiencing technical difficulties related to your location services, please scroll below to the section titled "QUESTIONS RE: LOCATION TROUBLESHOOTING" and "HOW TO ENABLE LOCATION SERVICES."

Q. What is the I Am Home raffle?

I Am Home is a raffle for a new home located at 3000 Whitstable Court, Thompson's Station, Tennessee 37179, with estimated value of \$634,000. The home is built by Willow Branch Partners LLC d/b/a Willow Branch Homes, and raffle proceeds benefit Monroe Carell Jr. Children's Hospital at Vanderbilt and e3 Partners Ministry, Inc. d/b/a I Am Second ("I Am Second"). The proceeds from raffle purchases will be deemed donations benefiting Monroe Carell Jr. Children's Hospital at Vanderbilt and I Am Second. Tickets are available online only and only persons with a digital device located in the state of Tennessee at the time of the purchase can buy a ticket. Each ticket is \$100.

Q. Where does the money from the ticket purchases go?

Proceeds support Monroe Carell Jr. Children's Hospital at Vanderbilt and I Am Second. Q. Can I buy more than one ticket?

Yes, you can buy more than one ticket. There is no limit to how many tickets may be purchased per transaction or by any one individual.

Q. When will the winning ticket be drawn?

The winning number will be announced on Saturday, November 27, 2021.

Q. How is the winning number drawn?

A unique winning number is randomly generated and issued by a computer out of the numbers purchased online for this draw. The winning number is randomly selected by representatives of the joint beneficiaries.

Q. Where can I see the winning ticket number?

The winning ticket number will be displayed on the Winners page of the [iamhomeraffle.com](https://www.iamhomeraffle.com) site.

Q. What do I do if I have the winning ticket?

To email us to confirm your winning ticket number, go to the Contact Us link on this page.

Q. I entered the incorrect email and did not print my tickets. How can I get my tickets re-sent?

Please go to the Contact Us link to request that the raffle manager email you your tickets.

Q. I purchased a ticket but did not get my number. What should I do?

If you purchased a ticket but did not receive your number, please check your email's junk or spam folders in the event it was flagged by your email provider. If you still do not have your ticket, contact us using the Contact Us link on this page and our support staff will resend your raffle number (some verification will be required). If your transaction is completed successfully, your number will still be part of the draw.

Q. When I am trying to process a transaction, it is not working. What can I do?

Please remember that when you are filling in the personal information at the checkout page, the address you input must match the address of the credit card that will be used for the transaction. Please ensure all fields are inputted correctly.

QUESTIONS RE: LOCATION TROUBLESHOOTING

Q. Why does this site require my location and/or why am I receiving the following prompt: "iamhomeraffle.com would like to use your current location"?

Your current location is required to confirm eligibility. The raffle will be offered to individuals located within the State of Tennessee (the "Raffle Area") at the time of purchase. Void outside the Raffle Area and where prohibited by law, rule, or regulation.

Q. What if I receive the following prompt: "You must allow your browser to share your location to purchase tickets. Please click "OK" to reload this page, then be sure to allow your browser to share your location to share your location when prompted"?

The browser should reload the page and ask you to share your location upon loading.

Note: In some browsers, the popup may say "close" instead of "OK." This message means you have not allowed your location to be shared. To purchase tickets, you have to share your location. To change your settings, please see the instructions below under the section titled "HOW TO ENABLE LOCATION SERVICES."

Q. What if I already selected "Don't Allow"?

Reloading the page should cause you to be prompted to share your location again. If you have specified that you never want to share your location, you will need to go into your settings to allow your location to be shared. To change your settings, please see the instructions below under the section titled "HOW TO ENABLE LOCATION SERVICES."

Q. I cannot purchase an I Am Home raffle ticket on iamhomeraffle.com. What should I do?

Per State of Tennessee regulations, you must be located within the state of Tennessee at the time of your ticket purchase. Your device's location services must be turned on to verify your location prior to entry to the online ticket purchase section of the iamhomeraffle.com site. Users must also agree to all Terms and Conditions outlined and be aged 18+.

Q. What if I receive one of the following prompts?

- "You must allow your browser to share your location to purchase tickets. Please enable location services for this browser and try again."
- "Location information is unavailable. In order to purchase tickets your location must be able to be determined. Please enable location services for this browser and try again."
- "The request to get user location timed out. In order to purchase tickets your location must be able to be determined. Please enable location services for this browser and try again."
- "An unknown error occurred while attempting to determine your location... In order to purchase tickets your location must be able to be determined. Please enable location services for this browser and try again."

These prompts are related to your location setting. You may have told your browser to never share your location. You have to change that setting before continuing with your ticket order. HOW TO ENABLE LOCATION SERVICES

Select one of these 4 devices to enable your access to the iamhomeraffle.com e-commerce site (iOS/Apple Mobile Devices, MacOS/Apple Desktop, Android-Based Mobile Devices, or Windows/PC Desktop.) Instructions for each are provided below.

iOS/Apple Mobile Devices:

To allow your location to be shared on an Apple device, you must adjust your settings in 2 different places, as follows.

FIRST: 1) Go to the Settings App. 2) Go to Privacy. 3) Go into Location Services. 4) Ensure Location Services are on. 5) Go to Share My Location and enable Share My Location. SECOND: 6) Return to Settings 7) Scroll down and click Safari 8) Click Location and select Allow or Ask (Note: Google Chrome has the same setting if you are using that instead.) You should be able to purchase a ticket now.

MacOS/Apple Desktop:

1) Check if Location Services is turned on by opening System Preferences. 2) Select Security & Privacy. 3) Select the Privacy tab. 4) Ensure Location Services is checked. 5) If it is not checked, click the lock icon in bottom right corner of that window to make changes. 6) Enter your username and password. 7) Check the Enable Location Services checkbox. 8) If it is checked, look at the list of allowed applications and make sure the web browser you are using is also checked. Note that Chrome will not show up here, but Safari and Firefox will. If Locations is on, you may have previously blocked the site from using locations. To unblock it, follow the instructions below for the browser you're using (Safari, Chrome, or Firefox).

-For Mac Safari: 1) Go to iamhomeraffle.com. 2) From the top browser menu, select Safari > Settings for this website. 3) In the pop-up under Location, select Allow.

-For Mac Chrome: 1) Go to iamhomeraffle.com. 2) Click the Buy Now button. 3) Receive the geolocation error. 4) In the Chrome address bar, identify the icon that looks like a compass/target with a small red X on it. 5) Click this icon. 6) On the window that opens, click Clear These Settings for Future Visits. 7) Click Done. 8) Go to iamhomeraffle.com. 9) Click the Buy Now button.

-For Mac Firefox: 1) Go to iamhomeraffle.com. 2) From the top menu, select Tools > Page info. 3) Click the Permissions tab. 4) Under Access Your Location, select Allow. 5) Retry your purchase on iamhomeraffle.com.

Android-Based Mobile Devices (Note: this may vary by version):

1) Go to the Settings App. 2) Go to Location and make sure that it is on. 3) Go back to previous screen and go to Apps. 4) Go to Chrome. 5) Click Permissions. 6) Ensure that Location is enabled. If you are still experiencing problems, go to a Maps app and see where it places you. (Please note that this can vary by version or smartphone model. On most Android phones, you can also pull down from the top of the screen to show several clickable settings. You can usually access Location here.)

If Location is on, you may have previously blocked the site from using the location. To unblock it: 1) Open Chrome. 2) Click on the three vertical dots in the top right corner. 3) Select Settings. 4) Under Advanced, select Site Settings. 5) Select Location. 6) In the upper right, click the magnifying glass. 7) Type iamhomeraffle.com. 8) If it appears in the search results, click it. 9) Click the Clear & Reset button that appears. 10) Retry your purchase on iamhomeraffle.com.

Windows/PC Desktop: Select your web browser below and follow the instructions.

-For Windows Chrome: 1) Go to iamhomeraffle.com. 2) Click the Buy Now button. 3) Receive the geolocation error. 4) In the Chrome address bar, identify the icon that looks like a compass/target with a small red X on it. 5) Click this icon. 6) In the window that opens, click Clear These Settings for Future Visits. 7) Click Done. 8) Go to iamhomeraffle.com. 9) Click the Buy Now button.

-For Microsoft Edge: 1) Go to iamhomeraffle.com. 2) Click on the three vertical dots in the top right corner of the web browser. 3) Click Advanced. 4) Under Website Permissions, click Manage Permissions. 5) Locate iamhomeraffle.com and select it. 6) Click Clear Permissions. 7) Retry your purchase on iamhomeraffle.com.

-For Windows Firefox: 1) Go to iamhomeraffle.com. 2) Right click an empty area on the page and select View Page Info. 3) Click the Permissions icon. 4) Under Access Your Location, select Allow. 5) Retry your purchase on iamhomeraffle.com.

Q. What if I still cannot purchase tickets on the website due to location issues?

You may have told your browser to never share your location. You need to change that setting to allow your location to be shared. If the steps above still do not allow you to share your location, try a different browser. If you are using Safari, try switching to Chrome or Firefox. If you're using Chrome, try Safari or Firefox. If you still cannot share your location, try clearing your browser's cookies and cache. These links explain how to clear your cookies and cache on Safari and Chrome:
