


What We Fund





The participatory grantmaking committee will decide on the grants. The committee will be composed of community members of color from across the region who have lived experience of racial inequities and are engaged in organizing and advocacy.

What is your funding priority?

We fund community and nonprofit organizations that are committed to racial equity and undertake community organizing, community engagement, and advocacy in the District of Columbia, Montgomery County and Prince George's County in Maryland, and Northern Virginia.

What should the one page narrative include?

This narrative should include a description of the organization's organizing and advocacy work that advances racial equity and engagement with Black,

Submit the following which are not included in the one page narrative.

- · Organization or project budget
- Diversity matrix

What is the grant amount that could be requested?


The grant range is \$15,000 to \$20,000.

What type of support does the foundation provide?

The foundation provides general operating support. For direct services organizations that undertake advocacy, they would receive a project support grant.

What types of organizations do you fund?

Our grantee partners have tax-exempt status under Section 501(c) (3) of the Internal Revenue Code or have fiscal sponsors.
