#### **FIRST AID**

IF ON SKIN Immediately flush with plenty of water while removing contaminated clothing. As soon as soap is available, wash thoroughly with soap and water. Wash clothing before reuse.

IF INHALED None normally needed. Remove to fresh air if breathing is difficult. Give oxygen and call a physician.

IF IN EYES Immediately flush with plenty of water for at least 15 minutes. Get medical attention.

### **DIRECTIONS FOR USE**

USE THIS PRODUCT ONLY AS SPECIFIED ON LABEL. PRELOAD™ water conditioner should be added to the spray water with adequate agitation prior to the addition of the glyphosate herbicide. Fill the tank half full, add PRELOAD™, finish filling, then add a glyphosate based herbicide. This should give time for

PRELOAD™ to react with the hard water cations. PRELOAD™ water conditioner is intended to tie up cations and condition the spray water. Use PRELOAD™ to condition the spray water for any amine salt herbicides and Paraquat and Diquat herbicides. Use rate 1 pint per 100 gallons of spray solution to 2 quarts per 100 gallons of spray solution depending upon water hardness. PRELOAD™ can be tank mixed with DRIFT-FIANT™ drift retardent agent. The concentration of PreLoad in the spray tank cannot exceed 10% of the total amount of formulated herbicides(s). Not for use with any other types of pesticides, such as insecticides or fungicides. PRELOAD™ provides 2lbs AMS at the 2qts/100 gal spray solution rate
