RESPONSE TO AUGUST 1, 2018 FINAL OFFICE ACTION

Dear Sir or Madam:

In the Office Action dated August 1, 2018 ("Office Action"), objection to the identification of goods was continued and a rewording of such identification required. Applicant respectfully disagrees that such a rewording is necessary, and would like to apprise the Examining Attorney of certain registrations which have issued within the past year having the "hand tools, namely, knives" wording in their respective identification of goods. These registrations include Registration Nos. 5,573,672 (SG® (and Design)); 5,464,705 (GRANDADDY®); 5,453,697 (GEAR DRIVE® (and Design)); 5,398,971 (HOOYMAN®); and 5,589,508 (KOJIRO®). While Applicant understands that each application is examined on its own merits and that Examining Attorneys are afforded latitude and discretion in review of applications, and in particular, are not necessarily bound by certain prior actions taken by the Trademark Office, Applicant nonetheless wanted to bring this information to the Examining Attorneys' attention, and if such information is favorably received,

requests reconsideration and acceptance of its proposed "hand tools, namely, knives" goods

identification wording.

In the alternative, if the Examining Attorney continues the refusal of Applicant's

proposed wording, then, without acquiescing in its position that its proposed wording should be

accepted, and solely in order to reduce the time and costs needed to achieve registration of its

mark, Applicant requests the identification of goods be amended to read: "hand tools, namely,

fixed blade knives, folding knives, and throwing knives; swords." This amended identification is

believed to be in compliance with the express requirements of the Office Action.
