This is in response to the Office Action dated March 21, 2019.

Identification of Services

The Office action states that the wording "other amenities" in the identifications of "Incubation services, namely, providing work space containing business equipment and other amenities to emerging, start-up and existing companies" and "providing shared office space containing business equipment and other amenities to emerging, start-up and existing companies" is indefinite and must be clarified to specify the "other amenities" provided. Applicant agrees to amend these services to the proposed specification in the Office action. The services will now read as follows:

"Incubation services, namely, providing work space containing business equipment and other **office** amenities **in the nature of a receptionist, meeting rooms, a mailroom, printing center, kitchen, and telecommunications equipment**, all for business purposes to emerging, start-up and existing companies"

"providing shared office space containing business equipment and other office amenities in the nature of a receptionist, meeting rooms, a mailroom, printing center, kitchen, and telecommunications equipment, all for business purposes to emerging, start-up and existing companies"

The Office action states that the phrase "business operation of commercial real estate, offices and office space for others, namely, providing shared office venues with conference facilities" requires specification. Applicant owns many applications in which the term is accepted.

Additionally, the Office action states that the phrase "providing coworking facilities for business purposes" requires specification. Applicant owns many registrations and applications in which the phrase "providing coworking facilities" did not require any further specification. Please see

the chart below. Applicant respectfully submits that these phrases are sufficiently specific and requests that these requirements be withdrawn.
