REQUEST FOR RECONSIDERATION AFTER FINAL OFFICE ACTION

This responds to the Final Office Action dated July 03, 2019, for U.S. Serial No. 88261921 for the mark UPP.

IDENTIFICATION OF SERVICES

Pursuant to the Examining Attorney's recommendations, Applicant respectfully requests the following amendment of its description of services:

Class 6: articles of metal or primarily of metal for use in or with pipes **and** pipework systems, namely, pipe couplings, pipe connectors, pipe fittings, flanges, flanges which have steel reinforcement rings, gaskets **for use in fuel and petrol service station installations** and bolts, ball valves **not being parts of machines** and flexible **pipe** connectors, **pipe fittings in the nature of** terminating reducers and terminating boots, stabilizer bars **for pipes, pipe fittings in the nature of** test ports, fusion seal **caps, pipe fittings in the nature of** boots for fusion seal, **ring-shaped pipe fittings of metal in the nature of** backing rings, jubilee **pipe** clips, **manually operated** pressure vent valves; pipe couplings of metal; metal pipe fittings in the nature of entry boots; **metal** pipe collars

Class 17: non-metallic **flexible** pipes; **non-metallic** flexible pipes for subterranean use in fuel and petrol service station installations; **non-metallic flexible** pipes for use in carrying petroleum or petroleum products including petrol and other fuels; primary, lined and secondary contained **non-metallic flexible** pipes; **flexible** pipes made from polyethylene; **non-metal fittings for pipes in the nature of** vents **and** vapor recovery lines for use with the aforesaid pipes; **non-metallic flexible** pipes, **non-metal pipe fittings in the nature of** pipe connectors and **non-metal** pipe junctions; **non-metal** pipe couplings, **non-metal pipe fittings in the nature of** connectors, sockets, elbows, T-junctions and tees, bends, reducers, termination and sliding electrofusion reducers, 5-bends, end caps, stubs, welding sockets, joints and seals, including electrofusion connectors; **non-metal pipe** couplings, **non-metal pipe** junctions, **non-metal pipe** joints, and **non-metal pipe fittings in the nature of** extensions; **plastic molded support bases for fuel dispensing pumps not being machine parts**; **non-metallic** seals **for fuel and petrol pipes** for stopping leakage of fluids; **portable non-metal** tank risers **for service station fuel storage tanks**; **non-metal pipe fittings in the nature of** entry boots; **non-metal** parts and fittings for the aforesaid goods

Class 20: non-metal pipe collars

Class 41: education, training and instruction, **namely, providing classes, seminars, and workshops in the field of** design, construction, repair, installation and maintenance of fuel and petrol service stations, including fuel and petrol service station forecourt installations, and including the design, installation, maintenance and repair of pipework, pipework systems, tanks, modular tank and canopy systems, service station buildings and associated constructions, for fuel and petrol service stations; advisory **services in the field of**

educational activities in the fields of design, construction, repair, installation and maintenance of fuel and petrol service stations

Class 42: certification, namely, testing, analysis, and evaluations of the training awards of others in the field of education on the subject of design, construction, repair, installation, and maintenance of fuel and petrol service stations to determine conformity with certification standards; certification, namely, testing, analysis, and evaluation of the educational services of others in the field of design, construction, repair, installation, and maintenance of fuel and petrol service stations to determine conformity with certification standards.

MARK DESCRIPTION

Pursuant to the Examining Attorney's recommendations, Applicant respectfully requests the following amendment of its description of services:

The mark consists of the **wording "UPP" in a stylized font. The wording appears inside two brush-stroked curved lines that form an incomplete oval. The lines are wider in the middle and taper down on the ends.**
