**REQUEST FOR RECONSIDERATION AFTER FINAL ACTION**

On October 11, 2019, the Examining Attorney issued a final office action (“Final Action”), refusing registration of Appln. No. 88/392,661 as to Class 36<sup>1</sup> based on the position that “the specimen of use does not indicate that applicant offers separate financial services in Class 36.” Applicant respectfully maintains its position that the specimen does show use in connection with the Class 36 services and that services need not be provided as an in-person “real activity performed by applicant,” which is the position taken in the Final Action. Contemporaneously, Applicant has filed a Notice of Appeal and respectfully requests, pursuant to Trademark Manual of Procedure (“TMEP”) Section 715.04, that the Trademark Trial and Appeal Board (“TTAB”) remands the above-captioned application to the Examining Attorney for review of the instant Request for Reconsideration.

**Argument**

Applicant argues that an incorrect bright-line standard has been applied here and that, as established by case law, the proper question is whether Applicant is performing the relevant Class 36 services through its software and whether consumers will and do associate the FINCHECK mark with these services, regardless of whether the steps of the services are performed by the software. Without providing any supporting rules<sup>2</sup>, case law or further explanation, the Final Action rejects the data sheet and software application images submitted by Applicant to show use in connection with the Class 36 services in the application based on the Examining Attorney’s position that,

[t]he specimen of use does not indicate applicant offer a separate financial service in Class 36 ... A service is a real activity performed by applicant, not a function of [a] software program used for financial purposes ... Simply put, a software application is not a financial service.

<sup>2</sup> The Final Action provides no support for the Examining Attorney’s position, but does cite to the rules surrounding the requirement that an application based on Section 1(a) must include a specimen showing the applied-for mark in use in commerce for each class of goods or services in the application and examples of specimens for services.

Applicant argues that this refusal is based entirely on incorrect, conclusory statements with no basis in law and that an incorrect standard has been applied.

The matter at hand is very similar to the issues dealt with in *In re. Jobdiva, Inc.*, 121 USPQ2d 1122 (Fed. Cir. 2016), where the Federal Circuit held, in summary, that a specimen showing use of a mark for software may also show use for services. JobDiva owned registrations for “personnel placement and recruitment” and, in support of its renewal application, submitted as a specimen a web printout showing that it offered software that allowed subscribers to locate pertinent jobs. The TTAB improperly applied a bright-line test that required JobDiva to show that it performed the personnel placement and recruitment services separate and apart from its software. In this case, the Federal Circuit articulated the correct test for evaluating specimens that refer to services but essentially are software driven, recognizing that software may be used by companies to provide services. The proper question is whether an applicant or registrant, through its software, performed the service(s) in question and whether consumers would associate the mark(s) at issue with those services, regardless of whether the steps of the service were performed by software. *See In re Jobdiva, Inc.*, 121 USPQ2d 1122.

Applicant’s Class 36 services include:

“Financial advisory and consultancy services; Financial information provided by electronic means; Financial information provided by electronic means in the field of online monitoring and tracking services for financial and e-commerce transactions relating to the status of securities and other financial instruments; Providing financial assessment services to others; Providing financial assessment services to others, namely, providing an online financial records aggregation service to aggregate and summarize personal and corporate banking, financial, investment and general financial information; Providing financial assessment services to others, namely, collecting and analyzing financial affairs records and summaries in the nature of bank accounts, investments accounts, bill payments, mortgages, retirement accounts, retirement programs, credit card accounts, insurance policies and loans all over electronic communications networks; Providing financial information; Providing financial information services to others; providing financial information services to others, namely, providing an online financial records aggregation service to aggregate and summarize personal and corporate banking, financial, investment and general financial information; Providing financial information services to others, namely, collecting and analyzing financial affairs records and summaries in the nature of bank accounts, investments accounts, bill payments, mortgages, retirement accounts, retirement programs, credit card accounts, insurance policies and loans all over electronic communications networks; Providing financial information services to others, namely, providing financial information in the form of records and summaries in the fields of financial affairs, bank accounts, investments accounts, bill payment, mortgages, retirement accounts, retirement programs, credit card accounts, insurance and loans by means of electronic communications networks; Providing financial information services to others, namely, providing online monitoring and tracking services for financial and e-commerce transactions relating to status of securities and other financial instruments,” in Class 36.

Applicant submits that, under the *In re Jobdiva, Inc.* test, it is clear that the specimen submitted in support of Applicant's Class 36 services should be accepted as showing use of these services.

**A. Applicant is Performing its Financial Services Through Its Software**

“Even though a service may be performed by a company's software, the company may well be rendering a service.” See *In re Jobdiva, Inc.*, 121 USPQ2d 1122. As summarized in the Final Action,

Applicant concedes in the response that (1) “the various financial services provided in connection with the FINCHECK mark **as part of the application.**” (2) “Per the datasheet, **through the app**, Applicant is ‘measuring a consumer's financial health using account and transaction data ...’ and (3) “Just because the FINCHECK mark is used in connection with the application itself does not mean that financial services cannot also be provided in connection with the FINCHECK trademark through the application” (emphasis in original).

Applicant disagrees with the Examining Attorney's negative suggestive use of “concedes” and, instead, reasserts herein these same points in support of its position that the specimen submitted shows use in connection with the relevant Class 36 services. As Applicant pointed out in its initial response, the specimen submitted details that the FINCHECK software acts as a “financial coach that dynamically measures consumers' financial health” and delivers “personalized insights and recommendations alongside financial coaching” – in other words, Applicant provides personalized and customized financial services to users through the software, all under the FINCHECK mark. Per the datasheet, through the software, Applicant is “measuring a consumer's financial health using account and transaction data ... [and] gaug[ing] financial health of the consumer, share contextual and personalized best practices, and suggest proactive actions to automate and improve their finances.” Under the *In re Jobdiva* test Applicant is providing “financial advisory and consultation services,” “financial assessment services,” “financial information services,” “financial information by electronic means” and other financial services through its software.

“With modern technology, the line between services and products sometimes blurs.” See *In re Jobdiva, Inc.*, 121 USPQ2d 1122, referencing *Jobdiva Rehearing*, 2015 WL 3542849, at \*2. “In today's commercial context if a customer goes to a company's website and accesses the company's software to

conduct some type of business, the company may be rendering a service, even though the service utilizes software.” *Id.* (quoting *In re Ancor Holdings*, No. 76213721, 2006 WL 1258813 (TTAB April 28, 2006)). Businesses no longer require physical locations or human interaction – consumers have adapted and come to expect services provided through technology - this does not take away from the connection the consumer makes between the service being provided and the relevant trademark. Especially in the financial space, with the evolution of technology and automation of services, consumers expect to have a software-based option for financial services, with some financial institutions moving entirely to software-based banking and forgoing physical locations.

**B. Consumers Will and Do Associate the FINCHECK Mark With The Services Provided Through Applicant’s Software**

“To determine whether a mark is used in connection with the services described in [an application], a key consideration is the perception of the user.” *In re Jobdiva, Inc.*, 121 USPQ2d 1122, citing *Lens.com, Inc. v. 1-800 Contacts, Inc.*, 686 F.3d 1376, 1381-82 (Fed. Cir. 2012). This “‘is a factual determination that must be conducted on a case-by-case basis,’ and there are many case-specific factors [to] examine.” *Id.* In this case, even where Applicant’s app performs each step of the financial services, the user will, and currently does, associate the FINCHECK mark with these services. Applicant’s use of its FINCHECK mark sufficiently creates in the minds of users an association between the FINCHECK mark and Applicant’s financial services. See *In re Jobdiva, Inc.*, 121 USPQ2d 1122, citing *Ancor Holdings*, 2006 WL 1258813, at \*3. Users download the software and consistently directly interact with the software in connection with the FINCHECK mark; all services are provided within the FINCHECK software application and the users are not redirected to another site or service provider.

Applicant providing its services through software is no different from the countless of other services providers doing the same in various fields. In *In re Jobdiva, Inc.*, the court references *On-Line Careline*, where it held that AOL had used its ONLINE TODAY mark in connection with “providing access to online computer services offering computer-industry news, commentary and product reviews,” even though those services were provided by software. 299 F.3d at 1088. Similarly, the following

sampling of trademark registrations (*see* Exhibit A) issued for services provided strictly by software and based on specimens showing these services provided by the various applications through software:

As further shown by this sampling, a specimen showing services being provided by software is not only an acceptable specimen, but a common (and perhaps even expected) specimen in the current age of technology.

### **Conclusion**

Using the appropriate test, it is without question that services can be provided through software and that the provision of services is not limited to just in-person activities, separate and apart from Class 9 software. Accordingly, Applicant requests that its already-submitted specimen, showing its financial services being provided through its software application in connection with the FINCHECK mark, be accepted as showing use in connection with its Class 36 services and that Appln. No. 88/392,661 be, accordingly, approved for publication.
