

Tracking purchase data with your SuperFleet Card is easy and convenient. Fuel type, gallons pumped, price per gallon, and location are printed on store receipts and recorded on your Fleet Report. The magnetic stripe on the back of the card allows you to restrict products (fuel only, fuel and oil, no restrictions) and a pin number may be added for security.
