DECLARATION OF JZCHAK WAJCMAN

15 I, Jzchak Wajcman, declare as follows:

1. I am the applicant for the above referenced trademark application. I make this
declaration in support of my application for registration of the mark XEROSTATIC on the
Principle Register and have personal knowledge of the matters stated herein.

20 2. The copy of the website which I submitted in respond to the first office action was an
initial draft of our website. The designer (Orian Graphic) which I hired to create the website
made a mistake when he used the phrase "treated with a special antistatic layer." The true
and correct manufacturer's description is as follows:

25 *A special polyethylene layer as an dielectric insulator material covering the core in
the cable plus a polyvinylchloride PVC jacket material which will help to cut noise
and reduce microphonics.*

The designer made up his own description which was not accurate and I failed to initially
catch and correct it. The website has since been corrected. Attached hereto is a true and
30 correct copy of the corrected website page.


3. The brochures that I provided in response to the first office action did not have any reference to an antistatic layer to reduce static noise and microphonics.

4. In our response to the first office action, I responded that XEROSTATIC is the phonetic equivalent of ZERO STATIC. Although this remains true, I do not believe that it has an significance because the word XEROSTATIC is also the phonic equivalent of X-ERO and ES-TATIC and a search of Google will show at least 3,700,000 results for XERO and 551,000 results for ESTATIC.

5. In conclusion, I strongly believe that the mark XEROSTATIC does not describe an ingredient, quality, characteristic, function, feature, purpose or use of the relevant goods which in this case are merely coaxial cable and coaxial cable connectors.

I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and, further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both under Section 101 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent or trademark issued thereon.
