### Introduction

Applicant enrich IT, Inc. (“enrich IT”) seeks to register its mark ENRICH IT (Serial No. 77/805,741) in International Class 42 in connection with various services. The Examiner has refused registration of the mark on the basis that the identification of services is indefinite and must be clarified. enrich IT responds to each requirement of clarification as set forth below, and requests that its mark be passed to publication.

### Discussion

**I. “Applicant should clarify that the consulting services are in the nature of computer software consultation.”**

enrich IT is amenable to the Examiner’s suggestion of revising the identified services to state: “Computer software consultation in the field of implementing, extending, upgrading, and maintaining software products.”

**II. “If by ‘providing software solutions’ applicant is referring to the service of providing temporary use of online, non-downloadable software, this must be specified and the specific function of the software must be identified.”**

enrich IT disagrees that the description “providing temporary use of online, non-downloadable software for use in . . . the field of business process outsourcing” accurately describes its services. enrich IT does not provide temporary use of online, non-downloadable software in connection with business process outsourcing. Rather, enrich IT provides its customers with a software solution in the form of an integrated technology platform that enables a customer to engage in business process outsourcing. An enrich IT brochure describing this software solution is attached as Exhibit “A”. In light of the Examiner’s concerns, however, enrich IT submits the following revised identification of its services: “providing technology platform software solutions in the field of business process outsourcing.”

**III. “Advice in the field of outsourcing strategy is a Class 35 service.”**

enrich IT hereby withdraws the phrase “providing advice to clients on business process outsourcing strategy” from its identification of services. Hence, a multiple-class application is not necessary for the ENRICH IT mark.

**IV. “The nature of the information technology support services must be specified.”**

Pursuant to TMEP § 1402.01, enrich IT hereby submits the following revised identification of services for the information technology support services that it offers: “information technology technical support services, namely, enterprise application software support services, database administration support services, customized software application development support services, and software testing services.”

Summary of revised identification

For the reasons stated above, enrich IT submits the following revised identification

of its services:

Computer software consultation in the field of implementing, extending, upgrading, and maintaining software products; providing technology platform software solutions in the field of business process outsourcing; information technology technical support services, namely, enterprise application software support services, database administration support services, customized software application development support services, and software testing services

**V. Disclaimer**

enrich IT hereby states that no claim is made to the exclusive right to use "IT" apart from the mark as shown.

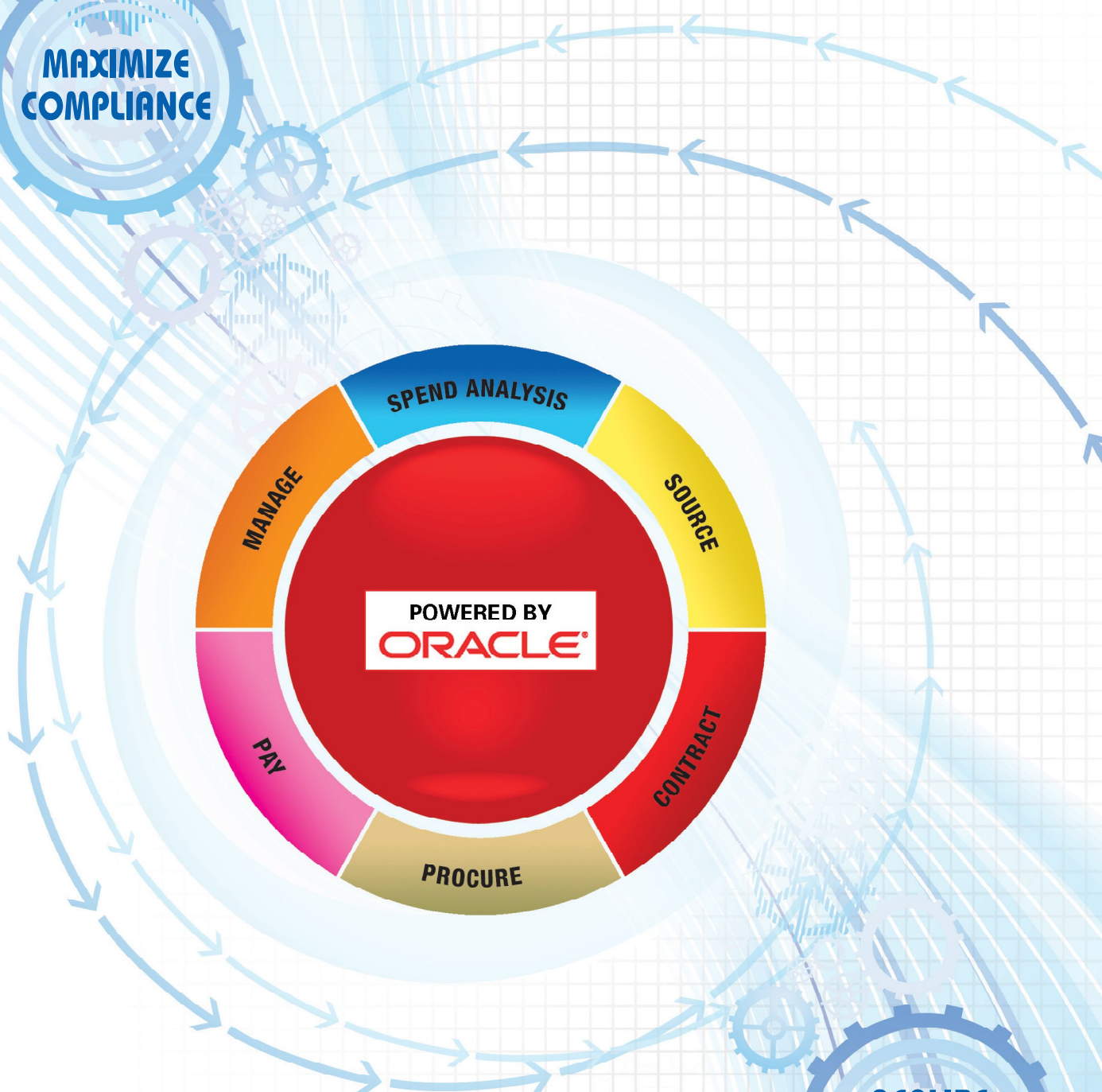
Conclusion

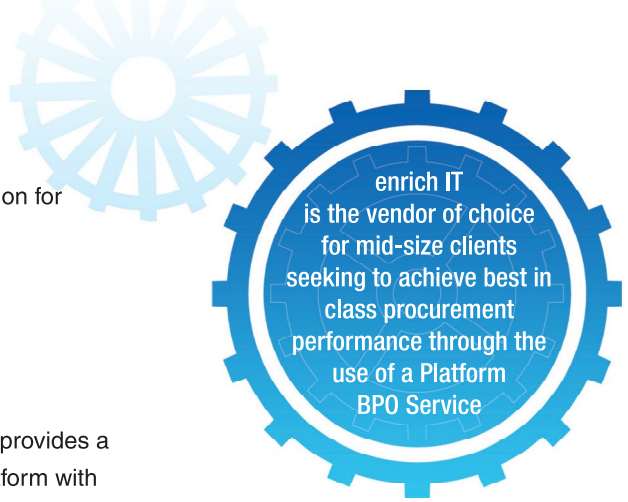

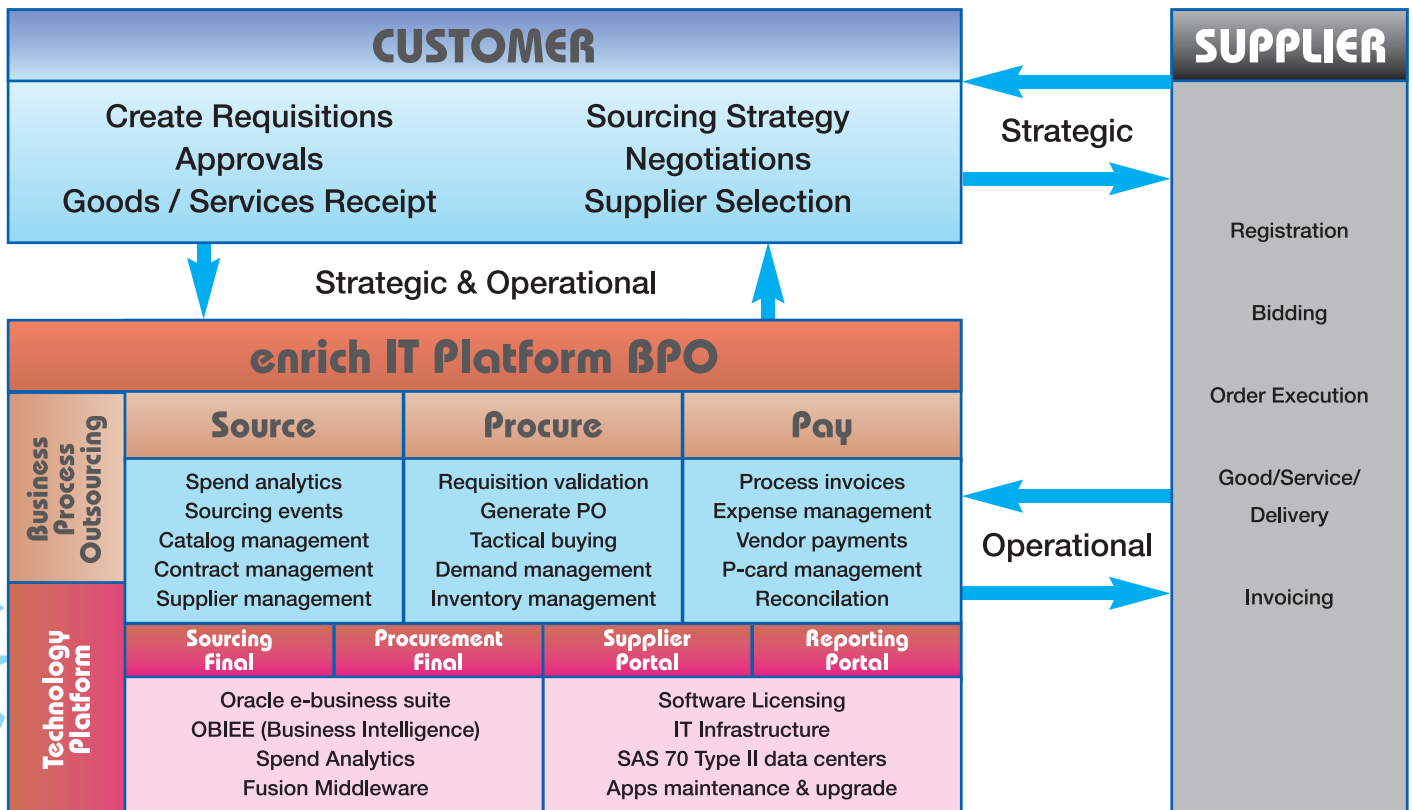

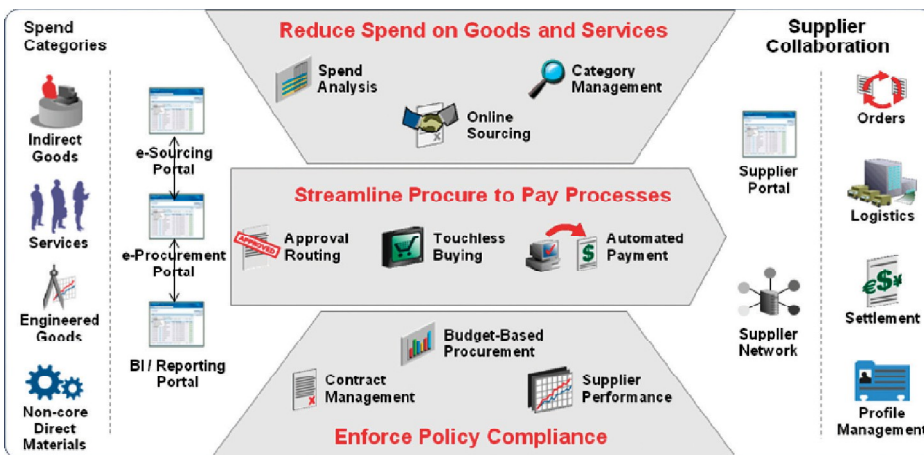
