## **CONSENT TO USE AND REGISTATION**

- b. The Hut.com will not seek to cancel Registration No. 4766288 for the mark MYPROTEIN.

Cend agrees that The Hut.com may seek to register the mark MYPROTEIN on and in connection with The Hut.com's Goods, and that no confusion is likely to result by virtue of the coexistence of both parties' marks in the USPTO. Cend further agrees that The Hut.com may present this document to the USPTO in support of its application to register the tradernark MYPROTEIN, namely, Application Serial No. 86/957042.

The parties agree that they shall cooperate in taking any reasonable action to avoid confusion and to correct any instances of likelihood of confusion which may come to their attention arising out of The Hut.com's use of the mark MYPROTEIN on The Hut.com's Goods and Cend's use of the mark MYPROTEIN on and in connection with Cend's Goods and Services.
