This submission is a timely response to the office action issued in this matter on September 14, 2016. Applicant respectfully submits the following comments with respect to its amendments to the goods that were refused by the Examining Attorney:

No.	Refused goods	Response
1	agricultural implements other than hand-operated, agricultural machines	<p>Applicant has amended this item as follows: “agricultural implements other than hand-operated and agricultural machines, <u>namely, combine harvesters, rice transplanters, binder, mobile threshers, rice huller, power tillers, bush cutter, vegetable transplanters, chaff cutter blades, corn harvesters cultivators being machines, ditchers being ploughs, grain husking machines, reapers and binders, reapers and threshers, sowers being machines, spraying machines, threshing machines</u>”.</p> <p>Applicant respectfully notes that the following wording was accepted in Ser. No. 85877979: “Combine harvesters, rice transplanters, binder, mobile threshers, rice huller, power tillers, bush cutter, vegetable transplanters.”</p> <p>With respect to the other goods, the same or almost identical goods are listed in the ID Manual or Nice Classification.</p>
2	pump	<p>Applicant has amended this item as follows: “pumps, <u>namely, pumps for machines, lubricating pumps, hydraulic pumps, fuel injection pumps</u>”.</p> <p>Applicant respectfully notes that the following wording was accepted in Ser. No. 85877979: “pumps, namely, pumps for machines, pump machines, gas heat pumps.”</p> <p>Applicant notes that “lubricating pumps, hydraulic pumps” are listed in the ID Manual.</p> <p>Applicant notes that “fuel injection pumps” was accepted in Reg. No. 5121967.</p>
3	construction machines and apparatus	<p>Applicant has amended this item as follows: “construction machines, <u>namely, excavator, wheel loader, backhoe loaders, front end loaders, concrete construction machines, power shovels, bulldozers, motorized all-terrain carriers, carriers being conveyor belts</u>”.</p>

		It is noted that nearly identical goods were accepted in App. No. 85877979.
4	loading-unloading machines and apparatus	Applicant has amended this item to “loading-unloading machines and apparatus ” per the Examining Attorney’s suggestion.
5	parts and fitting thereof	Applicant has amended this item to “ <u>replacement parts and fitting thereof</u> ” per the Examining Attorney’s suggestion.
6	machine elements not for land vehicles	Applicant has amended this item as follows: “machine elements not for land vehicles, <u>namely, bearings as parts of machines, gears for machines, reduction gears being parts of machines, shaft couplings as parts of machines, valves as machine components power transmissions and gearing for machines, not for land vehicles</u> ”. Applicant notes that these items are listed in the ID Manual.
7	snow blowers or snow throwers	Applicant has amended this item to “ <u>snow blowers and snow throwers</u> ” per the Examining Attorney’s suggestion.
8	industrial fishing machines	Applicant has amended this item as follows: “ <u>industrial fishing machines, namely, submersible automatic cleaners for fish farming nets</u> ”. It is noted that "submersible automatic cleaners for fish farming nets" was accepted in Ser. No. 85877979.
9	dairy machines	Applicant has amended this item as follows: “ <u>dairy machines, namely, milking machines, milk filtering machines, machines for udder cleaning and washing of dairy cows</u> ”. It is noted that these items are listed in the ID Manual.
10	packaging or wrapping machines and apparatus	Applicant has amended this item to “ <u>packaging and wrapping machines</u> and apparatus ” per the Examining Attorney’s suggestion.

With respect to the required legal entity type clarification, Applicant submits that the PTO has consistently accepted the designation “Corporation” as sufficiently identifying the legal entity type of the
