STATEMENT OF CONSENT

This Statement of Consent ("Consent") is made and entered into by Park Communications, LLC, a North Carolina limited liability company whose address is 9301 Globe Center Drive, Morrisville, NC 27560 ("Applicant"), and Millennium Photo Inc., a Japan corporation which lists the address of 1-9-25, Saiwai-Cho, Kawaguchi City, Saitama, Japan3320016 ("Registrant").

WHEREAS, Registrant owns U.S. Registration No. 4,737,069 for use of the mark MILLENNIUM in connection with "works of art in the nature of common and non-precious metal plates featuring the engraving, etching, printing, and painting of photographs, illustrations, images, graphic images or texts, in Class 6", and for "engraving, etching, printing, or sculpting of photographs, illustrations, images, graphic images, or texts on metal, ceramics, glass or stone, in Class 40";

WHEREAS, Applicant has applied for registration of the MILLENNIUM mark for use in connection with "commercial print services, offset lithography printing, digital print services, and printing of trading and gaming cards, in International Class 040", which has been assigned Application Serial No. 87/109,191and has been refused registration based upon a likelihood of confusion with Registrant's registration cited above;

WHEREAS, the parties believe that there exists no likelihood of confusion between their respective marks, and agree that each can have its own registration without creating any confusion in the marketplace and that such registrations can peacefully coexist; and

WHEREAS, the parties wish to resolve this dispute by means of a Statement of Consent;

NOW, THEREFORE, in consideration of the mutual covenants and obligations contained herein, the sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The parties, after careful consideration, agree that there is no likelihood of confusion between their respective marks and products for the following reasons:
 - a. Applicant has used its mark for commercial print services, offset lithography printing, digital print services, and the printing of trading and gaming cards, throughout the United States since as early as 2006;
 - b. The parties are not aware of any instance of actual confusion among consumers or members of the public arising from the use of their respective marks;
 - a. The products and services with which each party uses its mark differ; and
 - b. The channels of trade and marketing through which each party offers its products are distinct.

- 2. In the unlikely event that any confusion should arise in the marketplace, each party has agreed to use all reasonable efforts to avoid confusion with the other party and to work with each other to rectify any instances of confusion in the future, should they occur.
- 3. Based on the above factors, Registrant hereby consents to registration by Applicant of Application Serial No. 87/109,191 for the MILLENNIUM mark for the services listed therein.
- 4. This Consent shall both benefit and be binding upon the parties and their respective agents, affiliates, parents, subsidiaries, related companies, licensees, predecessors, successors and assigns.
- 5. Any individual signing this Consent on behalf of any party represents and warrants that he or she has full authority to do so.
