--"Music supervision services, namely, the selection, creation and production of music and content for use in television and film; music supervision services, namely, selection of music and content for use by television and film studios; music supervision services, namely, soundtrack development and score blueprinting for others for use in television and film; entertainment services in the nature of development, creation, production and post-production services of music and multimedia entertainment content for use in television programs and motion picture films; entertainment services, namely, music composition for films and television programs; soundtrack consulting, namely, music composition for others for use in films, television programs and commercials; music supervision services, namely, selection of music for use by entertainment companies in television and film; entertainment services, namely, original music production and composition services for use in advertising and commercials" in cl. 41; and

--"Licensing of intellectual property in the field of music" in cl. 45.--

REMARKS

Pursuant to the Office Action, the Examining Attorney requested clarification on certain aspects of Applicant's description of services and also noted that certain services (as amended) fall in cls. 35 and/or 45 and would therefore require payment of an additional filing fee per class added should Applicant wish to retain such services. In response thereto, Applicant has adopted the Examiner's suggested changes by adding cl. 45 (and paying the requisite filing fee) and has also transferred certain other services to and from Applicant's companion application for WALKER in cl. 35 as set forth under Appl. Ser. No. 87/113,327 in accordance with T.M.E.P. § 1402.08.
