## **AMENDMENT**

In response to the Official Action mailed November 3, 2017, please amend the above-identified application as follows:

Amend the identification of services to: "Providing online publications in the nature of magazines, in the field of design, architecture and décor.

## REMARKS

The Trademark Attorney has refused registration under Trademark Act Section 2(d), 15 U.S.C. Section 1052(d), based on the conclusion that Applicant's mark CLEVER is likely to be confused with the mark shown in U.S. Registration No. 4890550, namely CLEVER LITTLE MADAME.

The principal factors to be considered in determining whether there is a likelihood of confusion include: similarity of the marks, similarity of the goods or services and the similarity of the trade channels. <u>In re E.I. Dupont de</u> Nemours & Co., 476 F.2d 1357, 177 U.S.P.Q. 563 (CCPA 1973).

## SIMILARITIES OF THE MARKS

The mere fact that two marks may share a word or words in common is not dispositive of likelihood of confusion. Clairol, Inc. v. Cosmair, Inc., 224 U.S.P.Q. 229, 232 (S.D.N.Y. 1984) (SUMMER BLOND and SUMMER SUN for directly competitive hair lighteners sold through the same channels of

distribution are different enough in terms of name, packaging and impression to avoid likelihood of confusion by average customer). Even where common words may appear to be "dominant", courts have held that confusion is not likely, after considering marks in their entireties. In re Cooper Tire and Rubber Co., 22 U.S.P.Q. 2d 1079, 1080 (Fed. Cir. 1991) (THE INDY TUBE for rubber inner tubes is not likely to cause confusion with INDY 500 for tread rubber used on automobile tires. The court stated "even though we agree that in parsing the marks THE INDY TUBE and INDY 500, similarities can be found, we do not agree that the marks are, in their entireties, similar as to appearance, sound and commercial impression").

Applicant has applied to register CLEVER. The Trademark Attorney has cited a mark that includes the word "Clever" and the additional words "Little Madame." On their face the two marks are visually, audibly and contextually distinguishable.

The mere fact that cited Registrant's mark contains the word "clever" cannot be a basis for refusing registration to all other marks that incorporate that word. Applicant argues that the registrant Deborah Seidner does not have a monopoly on the word "Clever", even as it relates to class 35 and 41 services. Sections 807.03 and 1214.01 of the TMEP makes it clear that a single application or registration can protect only one mark, not a host of marks that could possible incorporate elements of the mark at issue. See, International Flavors, 51 USPQ2d at 1517-18. In addition, Applicant attaches a printout referencing over 60 Federal registrations which contain the word "clever" and which include services in Class 35 and/or 41. Thus, it is clear that the PTO

has determined that multiple parties may use and register "clever" on its own or with other words.

Applicant respectfully contends that the overall commercial impression, appearance and sound of the Applicant's mark and the cited mark are very different.

## DIFFERENCES IN THE GOODS AND SERVICES AND TRADE CHANNELS

Applicant's online magazine content focuses on design, décor and architecture. Published by the editors of Architectural Digest, the CLEVER site reads like a special issue of Architectural Digest with its focus on smart and intuitive design and décor ideas. The source of the materials, namely Architectural Digest is clearly identified. In stark contrast, the operator of Clever Little Madame is an individual who posts information in topical and diary formats wherein she tracks daily life and adds thoughts, opinions and things learned. Her website reads like a daily journal and is intended for general interest readers. The full name "Clever Little Madame" is always displayed and the source, namely Deborah Seidner, is prominently displayed on the site to remind users of the source of the materials.

When considered in their entireties, and not in a vacuum, the nature, context, subject matter and trade channels of both sites are easily distinguishable.

#### SUMMARY

When the relevant factors are considered, namely the differences in the marks, services content and trade channels, it is evident that there is no likelihood of confusion between Applicant's mark and the marks shown in the cited registration. Therefore, Applicant respectfully requests that the

Trademark Attorney withdraw the §2(d) refusal and pass the instant application to publication.
