- 1. <u>No Conflicting Marks</u>. The Applicant acknowledges that the trademark Examining Attorney has searched the Office's database of pending and registered trademarks and has found no conflicting marks that would bar registration under Trademark Act Section 2(d).
- 2. <u>Description of Mark</u>. Applicant adopts the following description of the applied for mark:

- 4. Recitation of Services. 
