Applicant submits the following amendments with regard to the present application.

AMENDMENTS

I. <u>ENTITY INDEFINITE</u>

In the Office Action, The Examining Attorney states that:

The designation "Inc." is included in applicant's name; however, the legal entity is set forth as "limited liability company." Generally, "Inc." identifies a "corporation," and not a limited liability company. Therefore, applicant must specify whether the legal entity is a limited liability company or a corporation and amend the application accordingly.

In response, Applicants requests the legal nature be amended to read, as follows:

Legal Entity:CorporationPlace Incorporated:Republic of Korea

II. <u>IDENTIFICATION OF GOODS</u>

In the Office Action, the Examining Attorney has rejected the application on the basis that the wording "MEDICAL DIAGNOSTIC TEST STRIPS" in the identification of goods is indefinite and must be clarified because the nature of use has not been specified.

In response, Applicant requests the description of goods be amended to read, as follows:

Cotton for medical purposes; **medical diagnostic test strips for use in the field of** *blood test and monitoring*; diagnostic test reagents for medical purposes, INT. CLASS 5.
