APPLICANT'S RESPONSE TO OFFICE ACTION DATED OCTOBER 15, 2018

TO THE COMMISSIONER FOR TRADEMARKS:

Aesculap AG ("Applicant"), by and through its undersigned counsel, hereby responds to the Office Action emailed October 15, 2018 ("Office Action"), on the above-captioned-trademark application for WERK_39 ("Applicant's Mark").

I. <u>INTRODUCTION</u>

The Examining Attorney has initially refused registration of Applicant's Mark WERK_39, Ser. No. 88/011858 in Classes 35, 36, 41, and 42 under §2(d) on the grounds that Applicant's Mark is likely to cause confusion with the following marks:

All of the Marks owned by NTT DOCOMO, Inc., herein are collectively referred to as the "WORK Marks". Collectively, the WERK Mark and the WORK Marks are referred to as "the Cited Marks". True and correct copies of the TSDR Reports for the Cited Marks are attached hereto as Exhibit "A."

Applicant respectfully disagrees with the Examiner's conclusion that a likelihood of confusion exists between Applicant's Mark and the Cited Marks, and requests withdrawal of the §2(d) refusal for the reasons set forth below in the Argument Section.

The Examining Attorney has also requested a copy of Applicant's Foreign Registration Certificate, clarification of Applicant's Services, and a translation statement. Applicant has incorporated its responses to the Examining Attorney's requests below.

II. FOREIGN REGISTRATION CERTIFICATE REQUIREMENT

Per the Examining Attorney's request, Applicant has provided a copy of its European Union Trademark certificate which is attached to this response as Exhibit "B."

III. <u>IDENTIFICATION OF SERVICES</u>

Per the Examining Attorney's request, Applicant has amended the services in Classes 35, 41, and 42 as follows:

• Class 35:

Business networking services; Business services, namely, planning concerning business management, namely, searching for partners for business establishments of joint ventures; Market analysis; Management services, namely business development services, namely providing start-up support for companies and businesses of others.

• Class 41:

Providing instructional seminars for educational purposes in the field of entrepreneurship; Providing workshops for training purposes in the field of entrepreneurship; Conducting courses, seminars and workshops in the field of entrepreneurship; Educational services, namely, providing training courses, conferences, exhibitions and competitions in the field of entrepreneurship; Career counseling and coaching, namely, providing advice concerning education options to pursue career opportunities; Coaching in economic and management matters.

Class 42: Development and implementation of computer programs; Development and implementation of computer software for project management; Software engineering; Software design and development; Computer programming; Development and implementation of programs for data processing; Development and testing of software; Programming of software for information platforms on the Internet for others; Development of database systems.

IV. ENGLISH TRANSLATION STATEMENT

The English translation of the word "WERK" in the mark is "FACTORY, PLANT, or FACILITY."

V. ARGUMENT

A. <u>Likelihood of Confusion Refusal</u>

1. <u>Introduction</u>

Applicant submits that the differences in the marks when compared in their entireties, the goods and services associated with the marks, and the crowded field of "Werk" and "39" formative registrations demonstrate that confusion is not likely. *See In re Viterra Inc.*,

671 F.3d 1358, 1361-62, 101 U.S.P.Q.2d 1905, 1908 (Fed. Cir. 2012); *In re Dakin's Miniatures Inc.*, 59 U.S.P.Q.2d 1593, 1595-96 (TTAB 1999); TMEP §§1207.01 *et seq*.

A determination of likelihood of confusion under Section 2(d) is made on a case-by-case basis and the factors set forth in In re E. I. du Pont de Nemours & Co., 476 F.2d 1357, 1361, 177 U.S.P.Q. 563, 567 (C.C.P.A. 1973) aid in this determination. Citigroup Inc. v. Capital City Bank Grp., Inc., 637 F.3d 1344, 1349, 98 U.S.P.Q.2d 1253, 1256 (Fed. Cir. 2011) (citing On-Line Careline, Inc. v. Am. Online, Inc., 229 F.3d 1080, 1085, 56 U.S.P.Q.2d 1471, 1474 (Fed. Cir. 2000)).

Not all the du Pont factors, however, are necessarily relevant or of equal weight, and any one of the factors may control in a given case, depending upon the evidence of record. Citigroup Inc. v. Capital City Bank Grp., Inc., 637 F.3d at 1355, 98 U.S.P.Q.2d at 1260; In re Majestic Distilling Co., 315 F.3d 1311, 1315, 65 U.S.P.Q.2d 1201, 1204 (Fed. Cir. 2003); see In re E. I. du Pont de Nemours & Co., 476 F.2d at 1361-62, 177 U.S.P.Q. at 567.

2. <u>Confusion is not Likely with the Cited Marks</u>

a. Confusion is not Likely with WERK Mark

When evaluating likelihood of confusion, the marks involved must be considered in their entireties. *See In re Hearst Corp.*, 25 U.S.P.Q.2d 1238, 1239 (Fed. Cir. 1992) ("Marks tend to be perceived in their entireties, and all components thereof must be given appropriate weight."). As a primary matter, it is essential to consider the meaning and connotation of the marks as a whole, as well as the appearance and sound of the marks. *Packard Pres., Inc., v. Hewlett Packard Co.*, 227 F.3d 1352, 1357 (Fed. Cir. 2000) ("holding that all relevant facts pertaining to appearance, sound and connotation must be considered before similarity as to one or more of those factors may be sufficient to support a finding that the marks are similar or dissimilar.").

Thus, in order to evaluate the similarity or dissimilarity of any two marks, the marks must be considered in their entireties. *See In re DuPont*, 476 F.2d at 1361 (noting that the first factor to be considered is "[t]he similarity or dissimilarity of the marks *in their entireties* as to appearance, sound, connotation and commercial impression" (emphasis added)); *see also In re Hearst Corp.*, 982 F.2d 493, 494 (Fed. Cir. 1992) (stating that all components of a mark must be given appropriate weight when evaluating likelihood of confusion); *Franklin Mint Corp. v. Master Mfg. Co.*, 667 F.2d 1005, 1007 (C.C.P.A. 1981) ("It is axiomatic that a mark should not be dissected and considered piecemeal; rather, it must be considered as a whole in determining likelihood of confusion.").

In this view, the WERK Mark is not a barrier to Applicant's Mark. Applicant's Mark WERK 39 differs in basic sound, appearance and commercial impression from the WERK Mark. The underscore in the WERK 39 Mark makes it appear that Applicant's Mark is either one distinct composite mark, or that there is a necessary connection between WERK and the cardinal number 39. As used in Applicant's Mark the word "WERK" means "plant, facility, or factory" when translated from German to English. Applicant is a related company of B. Braun and the number "39" in Applicant's Mark represents the year that B. Braun, was founded --1839. B. See Braun. History, **Tradition** and Innovation. available at https://www.bbraun.com/en/company/history.html (last accessed April 4, 2019 and attached as Exhibit "C"). These historic roots suggest a sense of permanence, established strength and growth, as well as market staying power. The mark as a whole suggests that a consumer utilizing Applicant's business incubator type services to promote its business model or growth plan will be "workshopped" or "processed" by Applicant in proven and effective ways to maximize the consumer's return on his or her investment. Accordingly, the inclusion of these

terms distinguishes Applicant's Mark from the WERK Mark, and makes clear that Applicant's Mark is used in connection with services related to business innovation.

By comparison, the WERK Mark is comprised of the word WERK alone. The translation statement for the WERK Mark indicates that as used in the mark, the word WERK means "work". Unlike Applicant's Mark, it cannot be viewed as a composite mark. Rather, the commercial impression of the WERK Mark is very straightforward, namely, that the owner of the WERK Mark is drawing attention to the fact that the services offered under the WERK Mark "Pattern printing; Printing of patterns on textiles; Prototype fabrication of new products for others", in Class 40 and "Teaching in the field of pattern making and clothing manufacturing; Providing on-line training courses, seminars, workshops in the field of pattern making and clothing manufacturing; Providing facilities for pattern making and clothing manufacturing training" in Class 41, are types of work (traditionally performed by an individual artisan, and/or by hand). These visual clues differentiate the marks, and make clear to the purchaser that the marks, and the goods and services offered under the marks, are distinguishable. See In Re Digiral Corp., 45 U.S.P.Q.2d 1841, 1998 WL 104305 (TTAB 1998) (No likelihood of confusion between DIGIRAY and DIGIRAD because knowledgeable buyers will be aware of the different connotations of RAY (short for x-ray) and RAD (which is a measure of radiation)).

Applicant does not dispute that the first word of both marks is "WERK." However, even if we were to compare the marks in their entireties WERK and WERK_39 the marks are not similar, even though they may contain a common term. The presence of a single common term alone is insufficient to establish that two marks are confusingly similar, or even share the same commercial impression. *See General Mills Inc.*, v. Kellogg Co., 824 F.2d 622, 627 (8th Cir. 1987) ("The use of identical, even dominant, words in common does not

automatically mean that two marks are similar."); see also e.g., In re Hearst Corp. 25 U.S.P.Q.2d at 1239 (marks VARGA GIRL and VARGAS sufficiently different in sound, appearance, and commercial impression for closely related goods); Pacquin-Lester Co. v. Pharmaceuticals Inc., 179 U.S.P.Q. 45, 46 (C.C.P.A 1973) (no likelihood of confusion between SILK for face cream and SILK 'N SATIN for beauty lotion and bath oil for hands and skin).

Furthermore, the amended services offered under the Applicant's Mark are vastly different from, and totally unrelated to, the services offered under the WERK Mark. Applicant's services are limited to the field of business consultancy, startup management and fundraising, and the development of computer programs. The owner of the WERK Mark is engaged in pattern printing and making, and teaching others about making clothes and clothing patterns.

It is very clear that the services under both marks are not related, and the marks are not likely to cause confusion.

b. Applicant's Mark and the WORK Marks are not Similar

As previously discussed, in order to evaluate the similarity or dissimilarity of any two marks, the marks must be considered in their entireties. *See In re DuPont*, 476 F.2d at 1361 (noting that the first factor to be considered is "[t]he similarity or dissimilarity of the marks *in their entireties* as to appearance, sound, connotation and commercial impression" (emphasis added)); *see also In re Hearst Corp.*, 982 F.2d 493, 494 (Fed. Cir. 1992) (stating that all components of a mark must be given appropriate weight when evaluating likelihood of confusion); *Franklin Mint Corp. v. Master Mfg. Co.*, 667 F.2d 1005, 1007 (C.C.P.A. 1981) ("It is axiomatic that a mark should not be dissected and considered piecemeal; rather, it must be considered as a whole in determining likelihood of confusion."). Thus, the Examiner must not dissect Applicant's Mark or the Work Marks. Rather, the Examiner must compare the entire WORK Design Mark and Second Work Design Mark, including its prominent design, which

consists of three, super-imposed, offset squares with brightly colored triangles which form the points of a polygon with the words "39 Works" prominently featured in the center as shown below:



with Applicant's Mark, which consists of the composite wording WERK_39 and contains no design element. *See* Exhibit "A", for a true and correct copy of the TSDR Reports for the Work Marks.

Here, the Examining Attorney must give due consideration to the prominence of the design element in the WORK Design Mark and Second Work Design Mark. It has long been held that proper weight should be given to the design element of a mark in determining whether there is a likelihood of confusion. *Tektronix, Inc. v. Daktronics, Inc.*, 189 U.S.P.Q. 693 (C.C.P.A. 1976); *see also Heartsprings, Inc. v. Heartspring, Inc.*, 143 F.3d 550, 555, 46 U.S.P.Q.2d 1481 (10th Cir. 1998) (plaintiff's proffered analysis to focus solely on the name runs against precedent); *see also In re Pacific Life Ins. Co.*, No. 76276166, 2004 TTAB *LEXIS* 254 at *12 (TTAB. Apr. 30, 2004) (finding design element sufficient to distinguish marks, even though applicant's and registrant's marks cover the same and related services).

A comparison of the respective marks without adequate consideration of a mark's design elements, especially when, as here, the design is the dominant element of the WORK Design Mark and Second Work Design Mark, ignores that "marks must be considered in the way

in which they are perceived by the relevant public." *In re Shell Oil Co.*, 992 F.2d 1204, 1206, 26 U.S.P.Q.2d 1687 (Fed. Cir. 1993). The test is not a side-by-side comparison of only the words in each mark, but whether the marks are sufficiently similar in their respective overall commercial impressions so that there is a likelihood of confusion. *See In re Henry Company*, 2001 TTAB *LEXIS* 385 (TTAB 2001). In fact, use of a distinctive design element is often helpful in distinguishing one mark from another. *See e.g. Parfums de Coeur Ltd. v. Lazarus*, 83 U.S.P.Q.2d 1012, 1016 (TTAB 2007) ("...the design is very noticeable and has the effect of catching the eye and engaging the viewer before the viewer looks at the word BODYMAN" helps distinguish the marks); *In re Aesgen, Inc.*, No. 76500182, 2006 TTAB *LEXIS* 286, at *6 (TTAB July 25, 2006) (not-precedential).

Here, a comparison of Applicant's Mark, consisting only of the wording WERK_39, and the Work Design Mark and the Second Work Design Mark, which consists of the wording "39 Works" surrounding a prominent, detailed design element, render the marks clearly and readily distinguishable from each other.

Even when comparing just the wording of the WORK Word Mark and the Second WORK Word Mark with Applicant's Mark, they differ in terms of basic sound, appearance, and commercial impression. "Works" is plural, whereas "Werk" in Applicant's Mark is singular which creates a distinct commercial impression. Furthermore, that the words in the marks consist of transposed terms also helps distinguish the word portions of the marks from one another. In fact, "the transposition of marks may serve as a basis to distinguish between them when the reversed combination creates a distinctly different connotation and/or is readily distinguishable in sound and appearance." *In re Mattress Firm, Inc.*, 2015 TTAB LEXIS 398, *16 (TTAB, 2015) (not precedential) citing *In re Akzona Incorporated*, 219 U.S.P.Q. 94, 96

(TTAB 1983) ("Applicant's mark 'SILKY TOUCH," conveys the impression that applicant's synthetic yarns are silky to the touch. On the other hand, registrant's mark 'TOUCH O' SILK," suggests that registrant's clothing products contain a small amount of silk.")); see also In re Mavest, Inc., 130 U.S.P.Q. 40 (TTAB 1961) (No likelihood of confusion between SQUIRETOWN for men's sport coats and TOWN SQUIRES for men's shoes); Murphy Brill and Shaner Inc. v. New Jersey Rubber Company, 102 U.S.P.Q. 420, 1954 WL 5510 (Comm'r Pat. & Trademarks 1954) (no likelihood of confusion between the marks "FLITE TOP" for hosiery and "TOPFLITE" for shoes because the marks convey different meanings).

Here, the transposition of the common terms creates a distinct commercial impression, which emphasizes the discrete meaning of the marks. In Registrant's Mark the number 39 precedes the word WORK, and is stylized 39WORKS (emphasis on the plurality). This suggest that there are thirty-nine discrete workspaces, or 39 discrete units or types of work that emanate from the mark. The numerous colored triangles in the design portion of the marks also heighten the sense of plurality, or multitudes. On the other hand, WERK_39 creates no such impression of multiples or multitudes. Rather, as described above, the number 39, which *follows* the word WERK in Applicant's Mark is meant to draw attention to the *singularity* and the proven quality and staying power of the methods utilized to perform the services emanating from Applicant's Mark. The order of the words in each mark draws attention to a different facet of the services of each – Registrant's sense of diversity and variety of services, and Applicant's sense of creativity and innovation.

Furthermore, it is well established that courts are "not concerned with mere theoretical possibilities of confusion, deception or mistake or with *de minimis* situations but with the practicalities of the commercial world which trademark laws deal." *Witco Chem. Co v.*

Whitfield Chem. Co., Inc., 418 F.2d 1403, 1405 (C.C.P.A 1967). Because of the differences between Applicant's Mark and the Cited Registration, consumers are not likely to be confused.

c. Applicant's Mark is able to Co-exist with the Cited Marks

In the October 15, 2018 Office Action, the Examining Attorney mistakenly indicates that Werkstatt Development Inc., is the owner of all registrations cited in the §2(d) refusal therein. Werkstatt is the owner of the WERK Mark only. The other Cited Marks are owned by NTT DOCOMO, Inc. This means that the Cited Marks have all been able to co-exist on the register without consumer confusion. In fact, the WERK Mark is one of 157 live applications and registrations for "Werk" formative marks on the register, and the NTT DOCOMO Marks are just a few of the 92 live applications and registrations for marks containing the number "39" on the register. A representative selection of the TSDR Reports for these Marks is attached as Exhibit "C". The staggering number of marks incorporating these terms cuts against any argument that there is a likelihood of confusion between Applicant's Marks and the Cited Marks. Consumers have grown accustomed to distinguishing between the different marks that include these terms. In re Broadway Chicken Inc., 38 U.S.P.Q.2d 1559, 1565,66 (TTAB 1996) (evidence of widespread third-party use of marks containing a certain shared term in each of these particular fields is "competent to suggest that purchasers have been condition to look to other common elements of the marks as a means of distinguishing the sources of goods or services in a field."). The registration of the Applicant's Mark would not result in increased confusion.

Accordingly, all the relevant factors weigh heavily against a likelihood of confusion.

VI. <u>CONCLUSION</u>

Applicant submits its mark is not likely to cause confusion with the Cited Marks, and respectfully requests the instant refusals be withdrawn and its application be allowed to proceed to publication.




