

This is in response to the Office Action dated December 7, 2018

In said Office Action, the summary of the Examiner's objections consists of 1) AMEND IDENTIFICATION; 2) AMEND CLASSIFICATION and 3) MULTI-CLASS REQUIREMENTS. Applicant addresses each of these matters as follows:

Examiner did not have any issues with Applicant's Class 09 goods and services, therefore, it will remain the same, specifically:

Class 009: Software for sports betting; Software for placing wagers on on-line casino gaming tables; software for placing wagers with on-line slot machines; software for placing wagers on on-line lottery games; Computer Game Software for playing casino table games; Computer Game Software for playing slot machines games; Computer Game Software for playing lottery games; Software for using mobile devices to place wagers on on-line casino gaming tables; Software for using mobile devices to place wagers with on-line slot machines; Software for using mobile devices for placing wagers for on-line lottery games; Software for using mobile devices to play on-line casino table games; Software for using mobile devices to play on-line slot machines; Software for using mobile devices to play on-line lottery games; Devices for wireless data transmission between point-of-sale lottery terminals and peripheral devices; Devices for wireless data transmission between slot machines and peripheral devices; Devices for wireless data transmission between casino table games and peripheral devices.

The Examiner has advised that the wording "services that enable users to place lottery wagers via mobile electronic devices" in the identification of services for International Class 041 is indefinite and must be clarified, as it appears to identify a technology service in International Class 042, which is where Examiner believes would be the proper classification for these services. Applicant has amended its goods and services in International Class 041, and has added International Class 042 to the existing application as the Examiner has requested as follows:

Class 041: Providing temporary use of non-downloadable computer games, wagering games, interactive real time gambling games, namely, bingo, poker, slot machines, all of the foregoing transmitted via a global computer network and via mobile phones, PDAs, and portable

electronic game systems; on-line casino services; providing gambling information relating to bingo, poker, slot machines, casino games, sports betting and bookmaking services all via a global computer network and via mobile phones, PDAs, and portable electronic game systems; entertainment services, namely, arranging and conducting interactive peer to peer gambling competitions, tournaments via global computer network, via social networking and via mobile phones, PDAs, and portable electronic game systems; organizing and conducting lotteries and other games of chance via a global computer network and via mobile phones, PDAs, and portable electronic game systems; betting services, namely, online gambling using a credit card to secure the funds; gambling consulting services relating to bingo, poker, slot machines, sports betting, bookmaking services and casino games

Class 042: Providing a lottery website featuring technology that enable users to place lottery wagers via mobile electronic devices; Providing a casino website featuring technology that enable users to place casino table game wagers via mobile electronic devices; Providing a casino website featuring technology that enable users to place slot machine wagers via mobile devices; Providing temporary use of non-downloadable software for sports betting transmitted via a global computer network and via mobile phones, PDAs, and portable electronic game systems

Applicant believes this should satisfy the Examiner's request, and that this application be allowed to proceed to registration.
