In response to the Office Action dated October 29, 2018, please amend the above-identified application as follows:

Please amend the identification of the goods/services as follows:

INTERNATIONAL CLASS 007

-- SORTING MACHINES IN THE NATURE OF ENVELOPE-SORTING MACHINES;
HIGH VOLUME SORTING MACHINES IN THE NATURE OF ENVELOPE-SORTING
MACHINES; INSERTING MACHINES IN THE NATURE OF ENVELOPE-INSERTING
MACHINES; HIGH VOLUME INSERTING MACHINES IN THE NATURE OF ENVELOPE-
INSERTING MACHINES; --

Please amend the color claim as follows:

-- THE COLORS BLUE AND WHITE ARE CLAIMED AS A FEATURE OF THE
MARK --.

Please amend the mark description as follows:

-- THE MARK CONSISTS OF A WHITE WAVE CRESTING IN A BLUE CIRCLE
BACKGROUND --.

REMARKS

The Examining Attorney has found the identification of goods as indefinite and must be clarified.

The identification of the goods in International Class 007 has been amended to “sorting machines in the nature of envelope-sorting machines; high volume sorting machines in the nature of envelope-sorting machines; inserting machines in the nature of envelope-inserting machines; high volume inserting machines in the nature of envelope-inserting machines”. It is respectfully submitted that the identification of the goods is acceptable.

The Examining Attorney has found the drawing shows the mark in colors that differ from those specified in the color claim. The Examining Attorney has required Applicant to submit a corrected color claim and mark description.

The application has been amended to submit a color claim that “the colors blue and white are claimed as a feature of the mark” and a mark description that “the mark consists of a white wave cresting in a blue circle background”. It is respectfully submitted that the drawing, color claim, and mark description all agree.

In view of the above, it is respectfully submitted that this application is believed to be in a condition to be passed to publication and favorable action toward this end is courteously requested.
