# RESPONSE

This is in response to the Office Action dated November 27, 2018.

#### Section 2(e)(4) Refusal

The Examining Attorney has preliminarily refused registration on the basis that the subject mark is primarily merely a surname. Applicant asserts that the refusal is traversed for the reasons set forth below.

## **STUDEBAKER Has Acquired Secondary Meaning**

Even if "Studebaker" has some surname significance, its principal significance is as a brand name. Applicant, as well as a number of third-parties have, registered the mark on the Principal Register for various goods and services without a claim of acquired distinctiveness. (See representative examples below and in the attached TESS printout.)

In particular, Applicant has used its STUDEBAKER mark in connection with its "electronic products" since at least as early as 2004 (see Reg. No. 3509858, issued Sept. 30, 2008). The mark should therefore be considered distinctive for these goods and the substantially similar goods associated with the subject mark under the natural zone of expansion.

## **Amended Description of Goods**

The Examining Attorney has requested clarification of certain goods listed in the application with suggested amendments. Applicant will adopt the Examining Attorney's suggestions in Classes 9 and 21 (but will not add Class 14 to the application), and requests that the descriptions be amended to read as follows:

**Class 9**: phonographic record players and turntables being record players; CD players, clock radios, namely, radios incorporating clocks

**Class 21**: record cleaning kits comprised of basins in the nature of receptacles, cleaning brushes, lint rollers, drying cloths, and liquid cleaning solution all for cleaning phonographic records

# **Conclusion**

Applicant requests that the refusal be withdrawn and that the subject application be accepted for publication.
