Response to Office Action

This is in response to the Office Action issued November 26, 2018.

Geographically Descriptive

In response to the refusal based on geographical descriptiveness, Applicant agrees to the Examining Attorney's suggestion and submits that the term "PRINCETON" in the subject mark has become distinctive of the services under Section 2(f) based on Applicant's ownership of U.S. Registration No. 1498976 on the Principal Register for the same mark for sufficiently similar services. Identification of Services

Applicant requests that the Examining Attorney amend the identification of services as follows:

- Class 35 (New): Providing incubation support, namely, marketing and clerical support for start-up ventures and a hub for entrepreneurship education
- Class 36: Providing incubation support, namely, financial and monetary support for startup ventures and a hub for entrepreneurship education
- Class 41 (New): Providing shared working space for students, faculty, staff and alumni to encourage collaboration and the exchange of ideas for educational purposes; providing space for events, workshops, and seminars for educational purposes to alumni, students and local entrepreneurs in the fields of entrepreneurship and innovation

Specimens

Applicant submits herewith specimens showing use of the mark in commerce for Classes 35 and 36, along with a supporting Declaration. Applicant notes that the specimen originally submitted with the application is acceptable for Class 41.




