a corporation organized and existing under the laws of and having a principal place of business at 404 Marie Victoran, Kingsley Falls, Quebec JOA 180 (hereinafter referred to as CASCADES).

WHEREAS, P & G is the owner of the following trade mark registrations in Canada:

AND WHEREAS, CASCADES has filed an application under Serial No. 600,514 in association with the following wares and services namely tube paper, head paper, box paper, insulation for pipelines, commercial paper, insulating felt for automobiles, impregnated coverings, dry coverings, caraboard for rolling boxes, white kraftboard, plantic ands for tubes; cases for wrapping coins, flush joints, cushioned envelopes, protective corners for wrappings, cardboard display stands, paper diapers, sanitary paper, toilet paper, asphalt coated felt, plastic foam containers, plastic, plastic foam molded paste; operation of a business specializing in

wastepaper recovery services, operation of a business specializing in ink removing services.

AND WHEREAS, P & C has obtained an extension of time to oppose that application.

AND WHEREAS, the parties are desirous of settling their differences.

NOW THEREFORE WITNESSETH, that in consideration of their mutual covenants P & G and CASCADES agree as follows:

- 2. CASCADES states that the nature of the impregnating substance used in impregnated coverings is not a detergent or cleansing substance. CASCADES further undertakes not to use a detergent or cleaning product as an impregnating substance on their paper products under the trade mark CASCADES;
 - CASCADES further undertakes and agrees not to use the trade material control of the cleaning product;
 - 4. Contingent upon CASCADES fulfilling the undertakings containe in paragraphs 1 3 of the present Agreement P & G agrees not to commence an Opposition to application No. 600,514 to regist the trade mark CASCADES and not to contest that registration in the future;

- Each party agrees to bear its own legal expenses and costs in connection with this settlement;
- Both parties agree to make any agreement between them binding on all directors, officers, employee, heirs, assigns and successors.
