RESPONSE TO OFFICE ACTION

On February 9, 2019, the Examining Attorney issued an Office Action refusing registration of Applicant Boldr Beverages, LLC's (the "Applicant") Serial No. 88169850 (the "Application") for the BOLDR mark (the "Mark") in Class 5.

In the Office Action, the Examining Attorney requested clarification of the identification of goods and stated that Applicant's Mark is likely to cause confusion with two U.S. trademark registrations: (1), BOLD, U.S. Registration No. 4392357, in Classes 5, 29, and 32 owned by BeBold Foods LLC, and (2) WILDE BOLDR, U.S. Registration No. 4823591, in Class 29 owned by Wilde Brands LLC (collectively "the Cited Registrations").

Applicant hereby submits an amendment to its identification of goods and presents arguments and evidence to support that there is no likelihood of confusion between Applicant's Mark and the Cited Registrations. As such, Applicant respectfully requests that the Examining Attorney reconsider her position and approve Applicant's Mark for publication.

I. Amendment to Identification of Goods

The Examining Attorney has objected to certain goods in the application and proposed amending the identification of goods in Class 5, if appropriate. Applicant amends the identification of goods as follows:

[Class 5]: Non-Medical Nutriceutical products solely in nature of powders **for use as a dietary supplement**, expressly excluding any liquid beverage, namely, nutritionally fortified beverages; Dietary supplements, expressly excluding nutritionally fortified beverages; Dietary supplements, namely, protein-based, nutrient-dense snack bars; powdered nutritional supplement drink mix containing one or more of the following ingredients, soy, oat oil, creatine, soy oil, dextrose, protein, non-fat milk, milk protein, or whey protein concentrate; dietary supplements; nutritional supplements **for weight loss purposes** in the nature of protein-based drinks, protein-fortified meal replacement bars, protein-fortified **snack energy** bars, and protein **supplements formed and packaged asbased food** bars; protein supplements; ready to drink nutritional **supplement** beverages for use as a meal **replacement beverages adapted substitute** for medical purposes; nutritionally fortified beverages for medical purposes; nutritional shakes for use as a meal substitute for medical purposes; dietary and nutritional supplements containing protein;

food supplements; nutritional supplements; dietary supplements in the nature of powdered drink mixes and weight loss powders; dietary supplement drinks, namely, nutritional supplements for weight loss, health and bodybuilding; dietary and nutritional food supplements and powdered drink mixes containing soluble and insoluble fiber; dietary and nutritional supplement for weight loss, diet, health, sports nutrition, body building, muscle gain and training; nutritional supplements in the form of non-fruit meal replacement bars and powders **for medical purposes**; and nutritional supplements in the form of non-chocolate meal replacement bars and powders **for medical purposes**; chocolate-based meal replacement bars and powders for weight loss purposes; nutritional supplement meal replacement bars and powders for boosting energy; Dietary and nutritional supplements, in gel, bar, powder and liquid form; vitamin supplements; mineral supplements; vitamins; vitamin, mineral, dietary and nutritional supplements.

There is No Likelihood of Confusion

The likelihood of confusion between two marks "is determined on a case-specific basis, applying the factors set out in *In re E.I DuPont DeNemours & Co.*, 476 F.2d 1357, 1361, 177 USPQ (BNA) 563, 567 (CCPA 1973) (enumerating factors that may be considered when relevant evidence is of record)." *Recot, Inc. v. Becton*, 214 F.3d 1322, 1326, 54 USPQ2d (BNA) 1894 (2000). These factors include:

- The similarity or dissimilarity of the marks in their entireties as to appearance, sound, connotation and commercial impression;
- The relatedness of the goods or services as described in the application and registration(s);
- The similarity or dissimilarity of established, likely-to-continue trade channels;
- The conditions under which and buyers to whom sales are made, i.e., "impulse" vs. careful, sophisticated purchasing;
- The number and nature of similar marks in use on similar goods;
- The existence of a valid consent agreement between the applicant and the owner of the previously registered mark.

Id. (citing *DuPont* 476 F.2d at 1361). Notwithstanding the above, "[t]here is no *mechanical test* for determining likelihood of confusion."

Here, the dissimilarities of the marks in their entireties as well as the goods covered in each respective mark outweigh any other relevant factors and should be dispositive of the issue of the likelihood of confusion.

A) There is No Likelihood of Confusion with the BOLD mark, U.S. Reg. No. 4392357 in Classes 5, 29, and 32 ("Cited Registration 1") owned by BeBold Foods LLC ("Cited Registrant 1")

i) <u>Comparison of Marks</u>

As set forth below, Applicant's Mark is not confusingly similar to Cited Registration 1 when the marks are properly considered in their entireties. *See DuPont*, 476 F.2d 1357, 1361, 177 USPQ 563 (CCPA 1973) (to determine the similarity or dissimilarity between two marks, one must compare the marks in their entireties as to appearance, sound, meaning and commercial impression). An analysis concerning a likelihood of confusion cannot be predicated on dissecting the marks into their various components; that is, the decision must be based on the *entire* marks, not just part of the marks. *Columbian Steel Tank Co. v. Union Tank & Supply Co.*, 125 USPQ 406 (CCPA 1960); *King of the Mountain Sports, Inc. v. Chrysler Corp.*, 51 USPQ2d 1349 (10th Cir. 1999). *See also Franklin Mint Corp. v. Master Mfg. Co.*, 667 F.2d 1005, 1007 (CCPA 1981) ("It is axiomatic that a mark should not be dissected and considered piecemeal; rather, it must be considered as a whole in determining likelihood of confusion").

Likelihood of confusion between Applicant's Mark and Cited Registration 1 cannot be assumed solely because the marks contain a term in common. Even when such marks are used on similar goods or services, the mere presence of such shared elements within the marks does not on its own make confusion likely. *Freedom Savs. & Loan Ass'n*, 757 F.2d at 1183 ("[T]he use of an identical word, even a dominant word, does not automatically mean that two marks are similar."); *In re Lancer Orthodontics, Inc.*, 1998 WL 377664, *2 (T.T.A.B. 1998) (no likelihood of confusion between IN ADVANCE and ADVANCE, both for dental products). In fact, the mere addition or deletion of a space or a single letter has sufficed to distinguish marks, even with respect to marks covering substantially similar services. *See McGregor-Doniger Inc. v. Drizzle Inc.*, 599 F.2d 1126, 1133, 202 U.S.P.Q. 81, 89 (DRIZZLE for ladies' coats not confusingly similar to DRIZZLER for golf jackets).

In the instant application, when comparing the marks, the Examining Attorney appears to have ignored the addition of the prominent letter "R" in Applicant's mark. When the marks are compared in their entireties, there are significant differences between the marks in overall appearance, sound and meaning, which render any likelihood of confusion unlikely.

First, the appearance and sound of the two marks are fundamentally different. Cited Registration 1, BOLD, consists of four letters, whereas Applicant's Mark, BOLDR, consists of five letters. The letter "R" is consequential, as it plays an important role as it adds the "er" sound in Applicant's Mark and the pronunciation of an additional syllable. White Cited Registration 1 consists of only one syllable, Applicant's Mark consist of two syllables due to the addition of the letter "R."

Additionally, the meaning of Cited Registration 1 is significantly different from that of Applicant's Mark. According to Merriam-Webster dictionary, the term "BOLD" has seven different dictionary definitions including fearless before danger, showing or requiring a fearless daring spirit, impudent and presumption, and assured and confident. Merriam-Webster's complete definition of 'bold" is attached as Exhibit A.

When a term is not a recognized word in the English language, there is no correct pronunciation of the mark. *See In re Belgrade Shoe Co.*, 411 F.2d 1352, 1353 (CCPA 1969).

"BOLDR" is a term created by the Applicant and not a recognized term in the English language. As such, there is no correct pronunciation or an official dictionary definition of the Applicant's Mark. When consumers encounter the BOLDR mark, they may pronounce it in several different ways, such as "BOLD-R," where the word "bold" and the letter "R" are pronounced separately. Alternatively, and more likely, some may understand the addition of the letter "R" as an "er" word, and thus pronounce the mark as "boulder" or "bolder." As such, consumers will interpret Applicant's Mark as "boulder", which Merriam-Webster defines as "a detached and rounded or much-worn mass of rock." Merriam-Webster's definition of "boulder" is attached as Exhibit B. Alternatively, some consumers will understand Applicant's Mark to mean the comparative adjective of the term "bold." Since there are multiple possible meanings of Applicant's Mark, it is unlikely that consumers will understand the mark to mean specifically one word. As such, the addition of "R" in Applicant's Mark is significant to the overall appearance, sound, and meaning of Applicant's Mark.

Furthermore, while consumers may understand Applicant's Mark as the phonetic equivalent of "boulder" or "bolder," it is obvious that Applicant's Mark is not a recognized word in the English language. Therefore, the deliberate misspelling of the Applicant's Mark creates a distinctive, unique word, enabling consumers to differentiate Applicant's Mark from Cited Registration 1. As such, a likelihood of confusion is unlikely.

Lastly, Applicant offers the following representative samples of contemporaneously registered marks owned by unrelated owners for goods in Classes 5 and 29. In all of these examples, like the case at hand, there is an overlapping component, with one mark having an additional letter "R" or the "er" sound. This supports the fact Applicant's Mark and the Cited Registration 1 can also peacefully co-exist on the register and avoid a likelihood of confusion. Copies of these registrations issued from the PTO are attached as Exhibit C.

As evidenced from the chart above, there are numerous peacefully co-existing marks — each for similar goods in Classes 5 and 29 where there is one overlapping term and an additional letter "R" or the "er" sound. As such, the Examining Attorney's position appears to be inconsistent with prior determinations shown over many years and by numerous different Examining Attorneys of the Trademark Office, which clearly supports the argument that Applicant's Mark and Cited Registration 1 are sufficiently different and unlikely to result in confusion.

ii) The Term "BOLD" Should be Afforded a Narrow Scope of Protection

The BOLD mark is diluted in connection with registrations for goods in Classes 5 and 29 Accordingly, the BOLD mark should only be afforded a narrow scope of protection. In a crowd of similar marks, customers will not likely confuse one mark for the other given that there are so many that co-exist. Customers will recognize that not all of the BOLD marks come from the same source. *See Standard Brands Incorporated v. RJR Foods, Inc.*, 192 USPQ 383, 385, 1976 WL 21135 (TTAB 1976); *In re Broadway Chicken Inc.*, 38 USPQ2d 1559, 1996 WL 253841 (TTAB 1996) ("Evidence of widespread third-party use, in a particular field, of marks containing a certain shared term is competent to suggest that purchasers have been conditioned to look to other elements of the marks as a means of distinguishing the source of goods or services in the field."). Further, "in a 'crowded' field, each member of the crowd, is relatively "weak" in its ability to prevent use by others in the crowd." J. Thomas McCarthy, *McCarthy on Trademarks and Unfair Competition*, § 11:85 at 11-163 (4th Ed. 2001).

Set forth below is a chart that lists numerous registered marks (and pending applications) at the PTO, which include the term "BOLD" in Class 5 or Class 29, that peacefully co-exist on the register. As seen in the chart below, Cited Registrant 1 is not the only trademark owner who has been granted the right to use the term "BOLD" in connection with goods in Classes 5 and 29.

Accordingly, Applicant's Mark should also be allowed to co-exist among these registrations. Copies of these registrations issued from the PTO are attached as Exhibit D.

Given the crowded field of "BOLD" marks, each owner is entitled to an extremely narrow scope of protection. As such, the evidence presented above clearly supports the arguments that Applicant's Mark and the Cited Registrations can peacefully co-exist on the Register amongst other trademark registrations that include the term "BOLD."

iii) Comparison of Goods Covered

Confusion is not likely, even where two marks are identical, "if the goods or services in question are not related or marketed in such a way that they would be encountered by the same persons in situations that would create the incorrect assumption that they originate from the same source." TMEP § 1207.01(a)(i). Furthermore, there is no per se rule that certain goods or services are related such that there must be a likelihood of confusion conclusion drawn from the use of similar marks in connection with such goods or services. TMEP § 1207.01(a)(iv).

Cited Registration 1 is for "Nutritionally fortified beverages" in Class 5, "Fruit-based food beverages" in Class 29, and "Energy drinks enhanced with vitamins, minerals, and nutrients" in Class 32. Applicant's application does not cover goods in Classes 29 and 32, therefore, these goods are not at issue in this case.

In contrast, Applicant offers dietary and nutritional food supplemental beverages with medical benefits. For example, Applicant's goods include "protein supplements," "dietary and nutritional supplements containing protein," "food supplements," "nutritional supplements," "dietary supplements in the nature of powdered drink mixes and weight loss powders," "dietary and nutritional food supplements and powdered drink mixes containing soluble and insoluble fiber; dietary and nutritional supplement for weight loss, diet, health, sports nutrition, body building, muscle gain and training," "nutritional supplements in the form of non-fruit meal replacement bars and powders and nutritional supplements in the form of non-chocolate meal replacement bars and powders," "chocolate-based meal replacement bars and powders for weight loss purposes," and "nutritional supplement meal replacement bars and powders for boosting energy"

Further, while Cited Registration 1 is for "nutritionally fortified beverages" in Class 5, Applicant expressly excludes these goods from its identification of goods, Applicant identification of goods in Class 5 reads, "non-medical nutriceutical products solely in the nature of powders, expressly excluding any liquid beverage, namely nutritionally fortified beverages; dietary supplements, expressly excluding nutritionally fortified beverages..." As such, since Applicant's goods are sufficiently distinct from the goods offered by Cited Registration 1, a likelihood of confusion is unlikely.

B) There is No Likelihood of Confusion with the WILDE BOLDR mark, U.S. Reg. No. 4823591 in Classes 5, 29, and 32 ("Cited Registration 2") owned by Wilde Brands, LLC ("Cited Registrant 2").

i) <u>Comparison of Marks</u>

As set forth below, Applicant's Mark is not confusingly similar to Cited Registration 2 when the marks are properly considered in their entireties. An analysis concerning a likelihood of confusion cannot be predicated on dissecting the marks into their various components; that is, the decision must be based on the *entire* marks, not just part of the marks. *Columbian Steel Tank Co. v. Union Tank & Supply Co.*, 125 USPQ 406 (CCPA 1960); *King of the Mountain Sports, Inc. v. Chrysler Corp.*, 51 USPQ2d 1349 (10th Cir. 1999). *See also Franklin Mint Corp. v. Master Mfg. Co.*, 667 F.2d 1005, 1007 (CCPA 1981) ("It is axiomatic that a mark should not be dissected and considered piecemeal; rather, it must be considered as a whole in determining likelihood of confusion").

Likelihood of confusion between Applicant's Mark and the Cited Registration 2 cannot be assumed simply because the marks contain a term in common. Even when such marks are used on similar goods or services, the mere presence of such shared elements within the marks does not on its own make confusion likely. *Freedom Savs. & Loan Ass'n*, 757 F.2d at 1183 ("[T]he use of an identical word, even a dominant word, does not automatically mean that two marks are similar."); *see also Time Inc. v. Peterson Publ'g Co.*, 173 F.3d 113, 119, 50 U.S.P.Q.2d 1474, 1478 (2d Cir. 1999) (no likelihood of confusion between TEEN and TEEN PEOPLE, both for magazines); *First Savs. Bank*, 101 F.3d at 653 (no likelihood of confusion between FIRST BANK and FIRST BANK SYSTEM marks); *Gruner + Jahr USA Publ'g v. Meredith Corp.*, 991 F.2d 1072, 1080, 26 U.S.P.Q.2d 1583, 1588 (2d Cir. 1993) (no likelihood of confusion between PARENT'S DIGEST, both for magazines); *In re Ferrero*, 479 F.2d 1395, 1398 (C.C.P.A. 1973) (no likelihood of confusion between TIC TAC for candy and TIC TAC TOE for ice cream); *In re Lancer Orthodontics, Inc.*, 1998 WL 377664, *2 (T.T.A.B. 1998) (no likelihood of confusion between IN ADVANCE and ADVANCE, both for dental products).

Here, the Examining Attorney has improperly dissected the Cited Registration 2 by ignoring the entire additional and most prominent element of the mark, namely, "WILDE," and based the citation solely on the use of the term "BOLDR." However, simply because Applicant's Mark and the Cited Registration 2 contain the term "BOLDR," the marks are not necessarily confusingly similar. Instead, when the marks are compared in their entireties, there are

significant differences between the marks in overall appearance, sound, and meaning, which serve to render confusion unlikely.

First, the appearances and sounds of the two marks are fundamentally different. Applicant's Mark is a unitary mark which consists of one word, "BOLDR," which is only five letters and consists of only two syllables. In contrast, Cited Registration 2 is composed of two separate and distinct words "WILDE" and "BOLDR." The additional term at the beginning of Cited Registration 2 creates an immediately difference impression and requires the pronunciation of two additional syllables, thus making the mark look and sound different in overall appearance and sound.

Further, the meaning of Cited Registration 2 is significantly different from that of Applicant's Mark. Cited Registration 2 includes the term "WILDE," a common American surname which is derived from "wild, violent, untamed." Explanations of the Wilde surname is attached as Exhibit E. As such, it can be argued that the surname reference in Cited Registration 2 serves as the most important part of the mark, since it serves as the identifier of the source of the goods provided by Cited Registration 2. Therefore, given the distinct difference in the overall meaning of the two marks and the important "WILDE", it is likely that consumers will not be confused as to the source of goods.

Lastly, to support this argument, Applicant offers the following representative samples of contemporaneously registered marks, owned by different owners, for related goods in Classes 5 and 29 (descriptions have been shorted for brevity). In all of these examples, like the case at hand, one mark is a standalone mark and the other includes the same mark along with an additional term. Copies of these registrations issued from the PTO are attached as Exhibit F.

More specifically, there are several examples where the PTO has allowed contemporaneously registered marks by unrelated owners for goods in Classes 5 and 29. In all of these examples, like the case at hand, there is an overlapping term, with one mark having the additional term "WILD." These registrations support the fact that Applicant's Mark and Cited Registration 2 can peacefully co-exist on the register and avoid a likelihood of confusion. Copies of these registrations issued from the PTO are attached as Exhibit G.

Accordingly, the evidence presented above clearly supports the arguments that Applicant's Mark and Cited Registration 2 can peacefully co-exist on the Register and avoid any likelihood of confusion.

ii) The Term "BOULDER" Should be Afforded a Narrow Scope of Protection

As stated above, in addition to "BOLD-R" and "bolder," some consumers may pronounce Applicant's Mark as "boulder." As shown in the chart below, there are numerous registered marks (and pending applications) at the PTO that include the term "BOULDER" in Classes 5 and 29 that peacefully co-exist on the Register. Therefore, the "BOULDER" mark should be afforded only a narrow scope of protection since it is diluted in connection with registrations for goods in Classes 5 and 29. Accordingly, Applicant's Mark should also be allowed to co-exist among these registrations. Copies of the registration issued from the PTO are attached as Exhibit H.

Given the crowded field of "BOULDER" marks, each owner is entitled to an extremely narrow scope of protection. As such, the evidence presented in the chart above clearly supports the argument that Applicant's Mark and Cited Registration 2 can also peacefully co-exist on the Register among other trademark registrations that include the term "BOULDER."

iii) Comparison of Goods Covered

As stated above, confusion is not likely, even where two marks are identical, "if the goods or services in question are not related or marketed in such a way that they would be encountered by the same persons in situations that would create the incorrect assumption that they originate from the same source." TMEP § 1207.01(a)(i). Furthermore, there is no per se rule that certain goods or services are related such that there must be a likelihood of confusion conclusion drawn from the use of similar marks in connection with such goods or services. TMEP § 1207.01(a)(iv).

Cited Registration 2 is for "Protein meat-based snack bars" in Class 29. Applicant does offer any goods under Class 29, but instead offers an entirely different type of "bars" to its consumers, as classified in Class 5. Applicant's products are not "meat-based" nor "snack" products," but instead have dietary, nutritional, and medical benefits. Applicant's goods include "powdered nutritional supplement drink mix containing one or more of the following ingredients, soy, oat oil, creatine, soy oil, dextrose, protein, non-fat milk, milk protein, or whey protein concentrate," "ready to drink nutritional beverages for use as a meal substitute for medical purposes," "nutritionally fortified beverages for medical purposes," "nutritional shakes for use as a meal substitute for medical purposes," and "dietary and nutritional food supplements and powdered drink mixes containing soluble and insoluble fiber." Accordingly, Applicant's products have a specific purpose to promote weight loss, diet, health, body building, and muscle gain and is not a mere snack bar for general consumption. In this regard, since Applicant's goods are sufficiently distinguishable from the goods offered by Cited Registration 2, a likelihood of confusion is unlikely.

I. <u>Conclusion</u>

In view of the foregoing arguments set forth above and the evidence submitted herewith, Applicant contends that Applicant's Mark is not likely to cause confusion with the Cited

Registrations. Therefore, Applicant respectfully requests that the Examining Attorney reconsider her position and approve Application Serial No. 88169850 for the BOLDR mark for publication in the *Official Gazette*.





The first is or rather well, well and the specific or the control of medieval nickname for a high spirited, or over boisterous person. The derivation is from the Old English pre 7th Century 'wilde' meaning undisciplined or out of control. Secondly the name may be residential for a person who lived on at a village called Wild, Wylde or Wilde, or from an area of uncultivated land called a weald. This was descriptive for a large area of land used only for grazing, and forming part of the local common grazing rights. The surname was first recorded in the latter part of the 11th Century, making it one of the earliest on record. Examples taken from surviving rolls and registers of those ancient times include: William le Wilde, in the 1177 Pipe Rolls of the county of Leicestershire, and Henry le Wylde, who appears in the Court Rolls of the county of Essex in 1236. William de Wilde, who was recorded in the Pipe Rolls of Sussex, in the year 1200, came from a place called Wilde. This may have been the village now called Wild, in Berkshire, or from some now 'lost' medieval site. Other recordings showing some of the spelling forms include: John Wyeld, who was christened on March 5th 1610 at St. Olave church, in Old Jewry, city of London, whilst Sarah Wield married William Atkins on August 3rd 1763 at St. George's church, Botolph Lane, also in the city of London. The first recorded spelling of the family name is believed to be that of Ulricus Wilde. This was dated 1086, in the Domesday Book of the county of Lincolnshire, during the reign of King William 1st of England, 1066 - 1087. Surnames became necess when governments introduced personal taxation. In England this was sometimes known as Poll Tax. Throughout the centuries, surnames in every country have continued to "develop", often leading to astonishing variants of the original spelling.


