Identification of Goods

In her Office Action, the Examining Attorney indicated that, "Applicant must clarify the wording 'Residential, business and personal wired and wireless security system comprising wired and wireless local area network video cameras, video monitors, closed circuit television (CCTV) monitors, surveillance cameras, motion sensitive security lights, infrared cameras, motion detector sensors, video capture devices, video capture and editing software, two-way radios, digital video recorders (DVRs) and computer hard drives for digital video recorders' in the identification of goods in International Class 009 because it is indefinite and too broad. See 37 C.F.R. §2.32(a)(6); TMEP §§1402.01, 1402.03. This wording is indefinite because the nature of the software is unclear as used within the system and it must be specified as 'downloadable' and/or 'recorded' to clarify the nature of goods. In addition, the nature of the video capture devices must be further specified."

At the Examining Attorney's request, Applicant amends the identification of goods as follows:

Wired and wireless security system for residential, business and personal use comprising wired local area network video cameras, wireless local area network video cameras, video monitors, closed circuit television (CCTV) monitors, surveillance cameras, motion sensitive security lights, infrared cameras, motion detector sensors, video capture cards, downloadable video capture and editing software, two-way radios, digital video recorders (DVR) and computer hard drives for digital video recorders; wireless local area network video camera; video cameras for wireless local area networks in Class 9.
