Art. R 714-8 A reference of all registrations with the National Trademark Register are subject to be entered into the Official Bulletin of Industrial Property.

All interested party may obtain from the Institute:

- 1° An identity certificate comprising the model of the trademark, information concerning the filing and the registration, where necessary, the restrictions to the list of goods or services resulting from a withdrawal, renunciation or a judicial decision.
 - 2° A copy of the registrations entered into the National Trademark Register;
 - 3° A certificate showing that no registration exists.
