

### **Trademark Co-Existence and Consent Agreement**

This Trademark Co-Existence and Consent Agreement is entered into this

20th day of June 2019 (the "Agreement") by and between LAMARTEK Inc. dba DIVE RITE, (hereinafter "DIVE RITE"), a Florida Corporation, having its principal place of business at 175 NW Washington Street, Lake City, Florida 32055, and INNOVATECH ENGINEERING, LLC, the Registrant, a Florida Limited Liability Company (hereinafter "INNOVATECH") located at 1650 Summit Lake Drive, Suite 103, Tallahassee, Florida 32317;



and joined by SUBMERSIBLE SYSTEMS, LLC, a California Limited Liability Company (hereinafter referred to as "SUBMERSIBLE") with a principal place of business located at 7413 Slater Avenue, Huntington Beach, CA.


**WHEREAS**, DIVE RITE is the owner of two separate United States Patent and Trademark Office ("USPTO") filed trademarks for the product commonly known as either the "NOMAD" or the "NOMAD SIDEMOUNT", a buoyancy compensator system specifically developed for the technical diver who generally dives in deep water, caves, for research, search and recovery, police and security, and other forms of technical diving.

On May 22, 2019 both the NOMAD and NOMAD SIDEMOUNT marks were filed by DIVE RITE with the United States Patent and Trademark Office (USPTO) Serial Numbers 88442367 and Serial No. 88442313 respectively. Both marks are based upon long time use in commerce worldwide since as early as November 6, 2006. DIVE RITE is using the marks, attached hereto as Exhibit A, in association with the goods described as,

*"Buoyancy compensator for scuba diving featuring a modular sidemount system that allows for single tank, double tank or sidemount diving and consisting of a wing, harness, butt plate, crotch strap, and adjustable bungee system."*

(hereinafter referred to as the "NOMAD or the NOMAD SIDEMOUNT")

**WHEREAS**, INNOVATECH is the owner of the USPTO Trademark registration 4993282 filed in logo format  for "regulators for use in scuba diving". The NOMAD regulator is part of a recreational snorkeling package and sold by Submersible Systems, LLC. The INNOVATECH mark  registered with the USPTO on April 19, 2016. See Exhibit B, the INNOVATECH NOMAD registered logo trademark attached hereto.



**WHEREAS**, The  is commonly sold as the EasyDive NOMAD in the marketing of the product. See photos of the EasyDive Nomad, attached hereto as Exhibit C. The first use of the EasyDive NOMAD is listed as 08/15/2015 and first use in commerce is listed as 09/08/2015, almost (9) years after the first use in commerce DIVE RITE's NOMAD and NOMAD SIDEMOUNT.

**WHEREAS**, SUBMERSIBLE has integrated the INNOVATECH NOMAD into its EasyDive recreational snorkeling/regulator system. The system is generally referred to as the EasyDive or the EasyDive Nomad and is used by recreational snorkelers who spend most of their time at the surface of the water and use the EasyDive system to dive under water in clear shallow conditions for short periods of time.

**WHEREAS**, technical divers and recreational snorkelers and/or divers generally move in different channels of commerce, in different environments and wear different types of equipment.

**WHEREAS**, the goods sold by each party under its respective mark are very different pieces of equipment from one another. The DIVE RITE NOMAD/ NOMAD SIDEMOUNT is a buoyancy compensator system and the INNOVATECH Easy Dive NOMAD sold by Submersible is a snorkel/regulator system. One is used to control buoyancy and the other is used to breath underwater.

**WHEREAS**, confusion between the products would be difficult and has never happened.

**WHEREAS**, DIVE RITE uses the marks NOMAD and NOMAD SIDEMOUNT on or in connection with its technical diving sidemount buoyancy compensator devices, namely the NOMAD XT, the NOMAD LS, the NOMAD LTZ and the NOMAD LT. All DIVE RITE products are well known to the technical diver population and each DIVE RITE product carries the USPTO registered trademarks DIVE RITE, the DIVE RITE flag logo  the DIVE RITE logo with Flag  on both the front and back of the product so that consumers are clearly aware of the maker of the product eliminating confusion between the company products. Any confusion would be extremely difficult. See Exhibit D, Dive Rite Nomad Sidemount. Also see Dive Rite company and logo USPTO Trademark Registrations 5548489 and 4125561 and 3157122, attached hereto as Exhibit E.

**WHEREAS**, the NOMAD/NOMAD SIDEMOUNT has been sold worldwide since 2006.

**WHEREAS** The EASYDIVE NOMAD has been sold in commerce since 2015.

**WHEREAS**, there has never been a single issue of confusion by any person, company, recreational diver, technical diver, snorkeler or non-diver between the products.

**WHEREAS**, both the EASYDIVE NOMAD and the NOMAD SIDEMOUNT systems are currently sold on the worldwide web through a variety of dealers with on-line retail stores, and through numerous dealers via retail or web-based avenues worldwide.

**WHEREAS**, INNOVATECH and SUBMERSIBLE wish to consent to the trademark registration by LAMARTEK INC. dba DIVE RITE of its trademark NOMAD serial number 88442367 and trademark NOMAD SIDEMOUNT serial number 88442313 on the United States Patent and Trademark Office Principal Register on the ground that, as used, and as set forth in this agreement, there is no likelihood of confusion between the parties' or their trademarks.

**WHEREAS**, DIVE RITE, INNOVATECH and SUBMERSIBLE desire to avoid and resolve any potential conflicts between them regarding their respective uses of their marks and logos bearing the words EASYDIVE NOMAD, NOMAD or NOMAD SIDEMOUNT, and will make efforts to avoid any potential confusion, mistake or deception on the part of the general public or members of the relevant merchandising trades with respect to ownership, use and registration rights; and

**WHEREAS**, the parties wish to end this matter without any further or formal proceedings.

**NOW, THEREFORE**, for and in consideration of the mutual representations, promises, terms and conditions contained herein, DIVE RITE, INNOVATECH and SUBMERSIBLE agree as follows:

**1. Consent to Co-Existence.**

**(a). Acknowledgment of Co-Existence.**

DIVE RITE acknowledges and INNOVATECH agrees that use of the above-referenced USPTO DIVE RITE trademarks NOMAD and NOMAD SIDEMOUNT existing on or before the date of this Agreement in connection with its company name, goods and services is not confusingly similar to INNOVATECH or SUBMERSIBLE's use of its above-referenced USPTO trademark NOMAD and all other INNOVATECH or SUBMERSIBLE marks such as EASYDIVE NOMAD existing on or before the date of this Agreement.

INNOVATECH reciprocally acknowledges and agrees that DIVE RITE's use of the DIVE RITE Marks for its buoyancy compensator system is not confusingly similar to INNOVATECH or SUBMERSIBLE's use of the INNOVATECH mark for the regulator or snorkel/regulator system, based on the differences in the respective products, marks and logos.

**(b). Registration and Consent.**

INNOVATECH and SUBMERSIBLE agree not to object to the registration of the DIVE RITE Marks. INNOVATECH and SUBMERSIBLE hereby consent to DIVE RITE's trademark registrations and use of the DIVE RITE Marks as trademarks in connection with the goods listed above as serial numbers 88442313 and 88442367.

DIVE RITE reciprocally agrees not to object to the INNOVATECH Mark or SUBMERSIBLE's EasyDive Nomad mark. DIVE RITE hereby consents to

INNOVATECH's USPTO filing for and registration of the mark NOMAD, USPTO Registration number 4993282 and use of the INNOVATECH Mark as its trademark in connection with the good listed and associated therewith.

2. **Further Actions.**

(a). DIVE RITE, INNOVATECH and SUBMERSIBLE each agree to take any reasonably necessary actions to avoid potential confusion regarding one another's trademarks.

INNOVATECH and SUBMERSIBLE agree not to use the INNOVATECH Marks in connection with any of the goods listed in DIVE RITE's trademark filings Serial Numbers 88442313 and 88442367. INNOVATECH and SUBMERSIBLE also agree not to use variations of the INNOVATECH Marks in a manner that would render them confusingly similar to the DIVE RITE Marks, including any variations that utilize the font or logo design elements found in the DIVE RITE MARKS.

DIVE RITE reciprocally agrees not to use the DIVE RITE Marks in connection with any of the goods or services listed in INNOVATECH's registered mark or SUBMERSIBLES EasyDive Nomad. DIVE RITE also agrees not to use variations of the DIVE RITE Marks in a manner that would render them confusingly similar to the INNOVATECH Marks or the SUBMERSIBLE mark, including any variations that utilize the font or logo design elements found in the INNOVATECH and SUBMERSIBLE marks.

(b). In the event that any party becomes aware of any actual confusion or mistake occurring as a result of the uses of their respective marks, the parties agree to communicate all details of each such instance to each other, and to cooperate reasonably to take steps to abate the cause of confusion or mistake, and to prevent any such confusion or mistake from arising again.

(c). INNOVATECH and SUBMERSIBLE agree not to oppose, petition to cancel, or otherwise challenge (legally or otherwise) the DIVE RITE Marks recently filed with the USPTO or in any other jurisdiction worldwide. DIVE RITE reciprocally agrees not to oppose, petition to cancel, or otherwise challenge (legally or otherwise) the INNOVATECH or SUBMERSIBLE Marks in the United States or in any other jurisdiction worldwide.

3. **Scope of the Agreement.** The scope of this Agreement shall be worldwide.
4. **Entire Agreement.** This Agreement shall be the entire agreement between the parties with respect to the subject matter herein. This Agreement supersedes any oral agreement, and the terms of this Agreement govern any prior agreements, proposals or other communications between the parties, whether oral or written.
5. **Amendment.** This Agreement may only be modified or amended by mutual agreement of authorized representatives of the parties in writing.



6. **Assignment.** This Agreement and the rights and obligations of any party hereunder may not be assigned by one party without the prior written consent of the other party, except for a merger or a sale of all or substantially all of the assets of the party or a sale of the entire product line(s) associated with the respective marks. In the event this Agreement is assigned by either party upon a merger, the sale or transfer of all or substantially all of its assets or the sale of the entire product lines associated with the respective marks, this Agreement shall be binding upon and inure to the benefit of the parties' successors and permitted assigns. A signed copy by the new owner should be forwarded to the respective recipient.
7. **Governing Law and Venue.** This Agreement shall be construed under the laws of the State of FLORIDA. The parties may mediate or arbitrate any and all disputes under this agreement upon mutual agreement. If no such mutual agreement can be reached within thirty (45) forty-five days following either party giving written notice to the other of such dispute(s), either party may then sue to enforce this Agreement in the United States District Court in Florida.
8. **Notices.** All notices shall be sent to the parties at the addresses set forth above. Notices shall be deemed received upon personal delivery or within five (5) days of deposit in the mail. Notices may be sent by email, courier, facsimile with confirmation or via registered mail.
9. **Counterparts.** This Agreement may be executed in counterparts, any one of which shall be deemed an original and all of which collectively shall be deemed a single instrument. A faxed, copied, electronic, or scanned signature shall be deemed an original signature.

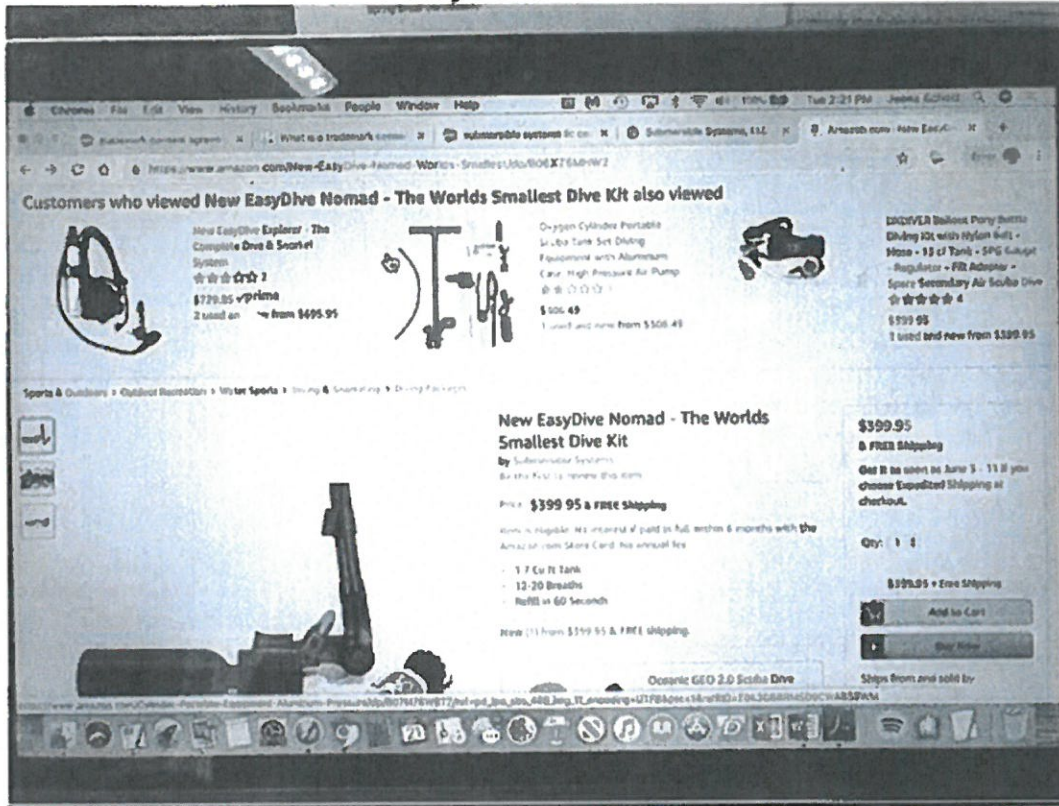
