Class 35: providing a website containing product reviews of the goods and services of others in the cannabis industry; arranging and conducting trade shows and industry business conferences in the field of cannabis goods and services

Class 41: educational services, namely, conducting seminars and conferences on the cannabis industry; providing a website featuring online, non-downloadable publications in the nature of periodicals and newsletters featuring cannabis goods and services; providing a website featuring non-downloadable videos in the field of information about cannabis industry goods and services and non-downloadable podcasts for businesses covering issues in the cannabis industry; entertainment services, namely, providing podcasts for businesses covering issues in the cannabis industry

# **REMARKS**

#### **Identification of Goods and Services**

The Examining Attorney has refused registration of the application on the ground the identification is indefinite/overbroad. Applicant has amended the identification substantially as suggested by the Examining Attorney, thus obviating the refusal. The amended identification is within the scope of the application as filed.
