<u>LIKELIHOOD OF CONFUSION WITH PRIOR REGISTRATION NOS. 4427319 AND</u> APPLICATION NO. 87045346

The Examining Attorney has also advised that there may be a likelihood of confusion between Applicant's Mark and Application Serial No. 87045346 for the mark X Stylized owned by Nutanix, Inc. Applicant requests suspension of the subject application pending disposition of the prior cited Application Serial No. 87045346.

Applicant is filing concurrently with this Response to Office Action a Request to Divide Application such that the Class 35 services in their entirety are divided into a separate application. The goods and services in the remaining classes, namely, 7, 9, 11, 36, 37, 42, will be divided into a new Child application. The divided services in Class 35 will remain pending in the Parent application.

FOREIGN REGISTRATION CERTIFICATE REQUIRED

Applicant respectfully notes that the foreign application to which the Applicant claims priority under Section 44 (d), namely Japanese Application No. 2018-100753, has matured to

registration but Applicant has not yet received the registration certificate. Applicant will submit a copy of the Japanese registration along with an English translation thereof once it is available.

CONCLUSION

In view of the foregoing amendments and remarks, Applicant respectfully requests that the Examining Attorney withdraw her requirement for clarification of identification of goods and

services against Application No. 88281362.
