The following remarks are in response to the Office Action issued on June 26, 2019.

I. <u>Potential Section 2(d) Refusal Based on Likelihood of Confusion with Application</u> 88042903

The Examining Attorney said that she may refuse registration under Section 2(d) of the Trademark Act based on the contention that OFFICE ("Applicant's Mark") for, as amended by this response, "Purses; wallets; umbrellas; travel cases; coin, credit card, business card, membership and loyalty card, banknote, label, ticket, document, and key holders; garment carriers, baby carrying bags, and animal carriers; carry-all and all-purpose carrying bags; handbags; parasols; *all of the foregoing excluding tote bags*" in Class 018 ("Applicant's Goods") is confusingly similar to this pending application, hereafter referred to as the "Pending Mark":

Applicant's Goods, as amended by this response, no longer conflict with the Pending Mark as the Applicant's Goods exclude tote bags. The Pending Mark already co-exists with several registrations for marks incorporating OFFICE for Class 18 bags and is thus very weak.

See Exhibit A. Therefore, the Applicant's Mark can also safely co-exist with the Pending Mark for distinguishable bags without causing a likelihood of consumer confusion.

II. Refusal Based on Registration No. 5160973

The Examining Attorney said, "both applicant and the registrant for OFFICE PAL offer spectacles and sunglasses." With this response, Applicant deleted "sunglasses" and "spectacles" and therefore asks the Examining Attorney to withdraw the refusal.

III. Refusal Based on Registration No. 2080325

The Examining Attorney said, "both applicant and the registrant for OFFICE ON WHEELS offer luggage." With this response, Applicant deleted "luggage" and therefore asks the Examining Attorney to withdraw the refusal.

IV. Refusal Based on Registration No. 4709071

The Examining Attorney says "the application uses broad wording to describe 'pouches', which presumably encompasses all goods of the type described, including the registered mark OFFICE WARRIOR's narrower 'fabric pouches sold empty that may be used to hold office supplies and equipment." With this response, Applicant deleted "pouches" and therefore asks the Examining Attorney to withdraw the refusal.

For the above reasons, Applicant respectfully requests that the Examining Attorney withdraw all refusals and approve Applicant's Mark for publication.
